12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

## Article - Courts and Judicial Proceedings

15 3-8A-03.

16 (a) In addition to the jurisdiction specified in Subtitle 8 of this title, the court 17 has exclusive original jurisdiction over:

18 (1) A child who is alleged to be delinquent or in need of supervision or 19 who has received a citation for a violation;

20 (2) Except as provided in subsection (d)(6) of this section, a peace order 21 proceeding in which the respondent is a child; and

22 (3) Proceedings arising under the Interstate Compact on Juveniles.

(b) The court has concurrent jurisdiction over proceedings against an adult for24 the violation of § 3-8A-30 of this subtitle. However, the court may waive its

1 jurisdiction under this subsection upon its own motion or upon the motion of any

2 party to the proceeding, if charges against the adult arising from the same incident

3 are pending in the criminal court. Upon motion by either the State's Attorney or the

4 adult charged under § 3-8A-30 of this subtitle, the court shall waive its jurisdiction,

5 and the adult shall be tried in the criminal court according to the usual criminal 6 procedure.

7 (c) The jurisdiction of the court is concurrent with that of the District Court in 8 any criminal case arising under the compulsory public school attendance laws of this 9 State.

10 (d) The court does not have jurisdiction over:

11 (1) A child at least 14 years old alleged to have done an act which, if 12 committed by an adult, would be a crime punishable by death or life imprisonment, as 13 well as all other charges against the child arising out of the same incident, unless an 14 order removing the proceeding to the court has been filed under § 4-202 of the 15 Criminal Procedure Article;

16 (2) A child at least 16 years old alleged to have done an act in violation of 17 any provision of the Transportation Article or other traffic law or ordinance, except an 18 act that prescribes a penalty of incarceration;

19 (3) A child at least 16 years old alleged to have done an act in violation of 20 any provision of law, rule, or regulation governing the use or operation of a boat, 21 except an act that prescribes a penalty of incarceration;

22 (4) A child at least 16 years old alleged to have committed any of the 23 following crimes, as well as all other charges against the child arising out of the same 24 incident, unless an order removing the proceeding to the court has been filed under § 25 4-202 of the Criminal Procedure Article:
