0 (a) (1) The local department in each county shall have a board, appointed as 1 hereinafter provided and herein referred to as the local board. [Except as provided in paragraph (3) of this subsection, the] THE local board shall be composed of [nine members] AT LEAST NINE BUT NO MORE THAN 13 MEMBERS, AS PROVIDED BY LOCAL LAW AND ENACTED BY THE LOCAL GOVERNING AUTHORITY. The members shall receive no salary for their services, but their reasonable expenses incurred in attending meetings or performing other official duties shall be paid. Each local board shall select its own chairman on July 1st of each year.
(2) Each local board chairman shall serve as liaison between the local board and the State Board.
[(3) (i) In Frederick County and in Garrett County, the local board shall be composed of at least 9 but no more than 13 members, as determined by the Board of County Commissioners.
(ii) In Harford County, the local board shall be composed of at least 49 but no more than 13 members, as provided by local law enacted by the County Council and approved by the County Executive.
(iii) In Montgomery County, the local board shall be composed of at least 9 but no more than 13 members, as provided by local law enacted by the County Council and approved by the County Executive.
(iv) In Baltimore City, the local board shall be composed of at least 9 but no more than 13 members, as provided by local law enacted by the Mayor and City Council of Baltimore City.]
