- 2 Valid Marriages
- 3 FOR the purpose of adding a new section to the Maryland Constitution to establish
- 4 that only a marriage between a man and a woman is valid in this State; and
- submitting this amendment to the qualified voters of the State of Maryland for
- 6 their adoption or rejection.
- 7 BY proposing an addition to the Maryland Constitution
- 8 Article XV Miscellaneous
- 9 Section 8
- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, (Three-fifths of all the members elected to each of the two Houses
- 12 concurring), That it be proposed that the Maryland Constitution read as follows:
- 13 Article XV Miscellaneous
- 14 8.
- 15 ONLY A MARRIAGE BETWEEN A MAN AND A WOMAN IS VALID IN THIS STATE.
- 16 SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly
- 17 determines that the amendment to the Maryland Constitution proposed by this Act
- 18 affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the
- 19 Maryland Constitution concerning local approval of constitutional amendments do
- 20 not apply.
- 21 SECTION 3. AND BE IT FURTHER ENACTED, That the aforegoing section
- 22 proposed as an amendment to the Maryland Constitution shall be submitted to the
- 23 legal and qualified voters of this State at the next general election to be held in
- 24 November, 2006 for their adoption or rejection in pursuance of directions contained in
- 25 Article XIV of the Maryland Constitution. At that general election, the vote on this

- $1 \ \ proposed \ amendment \ to \ the \ Constitution \ shall \ be \ by \ ballot, \ and \ upon \ each \ ballot$
- 2 there shall be printed the words "For the Constitutional Amendment" and "Against
- 3 the Constitutional Amendment," as now provided by law. Immediately after the
- 4 election, all returns shall be made to the Governor of the vote for and against the
- 5 proposed amendment, as directed by Article XIV of the Maryland Constitution, and
- 6 further proceedings had in accordance with Article XIV.
