13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

17 18	(a) (1) This section applies to any person charged with a violation of the Maryland Vehicle Law for exceeding, as to any vehicle or combination of vehicles:
19 20	(i) The maximum registered weight limit for which the vehicle or combination is registered;

- [(e)] (F) (1) If the vehicle being operated at the time the offense is
- 14 committed is registered outside of this State, or if the person responsible for the
- 15 violation or the person operating the vehicle is a nonresident of this State, further
- 16 proceedings shall be had as to the person under Title 26 of this article or the vehicle
- 17 shall be impounded until the fine is paid or acceptable collateral posted.
- 18 (2) The impounding of the vehicle does not include the cargo, and the 19 cargo may not be held.
- 20 (3) If, after 90 days from the date the vehicle was impounded, the fine
- 21 has not been paid or acceptable collateral posted, the vehicle may be sold at public
- 22 auction under the jurisdiction of the court to satisfy the fine, accrued interest, and
- 23 costs.
- 24 [(f)] (G) The provisions of this section do not apply to an "emergency vehicle",
- 25 as defined in § 11-118 of this article, when responding to an emergency.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
