- 3 FOR the purpose of authorizing a local government to purchase certain street lighting
- 4 equipment from an electric company; requiring a local government to pay fair

- 4 (A) IN THIS SECTION, "ELECTRIC COMPANY" HAS THE SAME MEANING AS 5 PROVIDED IN § 1-101 OF THE PUBLIC UTILITY COMPANIES ARTICLE.
- 6 (B) ON WRITTEN REOUEST BY A LOCAL GOVERNMENT, AN ELECTRIC
- 7 COMPANY SHALL SELL TO THE LOCAL GOVERNMENT SOME OR ALL OF THE ELECTRIC
- 8 COMPANY'S EXISTING STREET LIGHTING EQUIPMENT THAT IS LOCATED WITHIN THE
