- 2 Creation of a State Debt - Prince George's County - Children's Guild 3 **Multipurpose Room and Play Field**
- FOR the purpose of authorizing the creation of a State Debt not to exceed \$425,000,
- 5 the proceeds to be used as a grant to the Board of Trustees of The Children's
- Guild, Inc. for certain development or improvement purposes; providing for 6
- disbursement of the loan proceeds, subject to a requirement that the grantee 7
- 8 provide and expend a matching fund; establishing a deadline for the
- encumbrance or expenditure of the loan proceeds; and providing generally for 9
- the issuance and sale of bonds evidencing the loan. 10
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11
- 12 MARYLAND, That:
- 13 (1) The Board of Public Works may borrow money and incur indebtedness on
- 14 behalf of the State of Maryland through a State loan to be known as the Prince
- 15 George's County Children's Guild Multipurpose Room and Play Field Loan of 2006
- 16 in the total principal amount equal to the lesser of (i) \$425,000 or (ii) the amount of
- 17 the matching fund provided in accordance with Section 1(5) below. This loan shall be
- 18 evidenced by the issuance, sale, and delivery of State general obligation bonds
- 19 authorized by a resolution of the Board of Public Works and issued, sold, and
- 20 delivered in accordance with §§ 8-117 through 8-124 of the State Finance and
- 21 Procurement Article and Article 31, § 22 of the Code.
- 22 The bonds to evidence this loan or installments of this loan may be sold as
- 23 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 24 § 8-122 of the State Finance and Procurement Article.
- 25 The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 26 and first shall be applied to the payment of the expenses of issuing, selling, and
- 27 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 28 shall be credited on the books of the Comptroller and expended, on approval by the
- 29 Board of Public Works, for the following public purposes, including any applicable
- 30 architects' and engineers' fees: as a grant to the Board of Trustees of The Children's
- 31 Guild, Inc. (referred to hereafter in this Act as "the grantee") for the design,

- 1 construction, and capital equipping of a parking lot, play field, and multipurpose 2 room, located in Chillum.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds as and 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- $8\,$ purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property or in kind
- 12 contributions. The fund may consist of funds expended prior to the effective date of
- 13 this Act. In case of any dispute as to the amount of the matching fund or what money
- 14 or assets may qualify as matching funds, the Board of Public Works shall determine
- 15 the matter and the Board's decision is final. The grantee has until June 1, 2008, to
- 16 present evidence satisfactory to the Board of Public Works that a matching fund will
- 17 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 (6) The proceeds of the loan must be expended or encumbered by the Board of
- 23 Public Works for the purposes provided in this Act no later than June 1, 2013. If any
- 24 funds authorized by this Act remain unexpended or unencumbered after June 1,
- 25 2013, the amount of the unencumbered or unexpended authorization shall be
- 26 canceled and be of no further effect. If bonds have been issued for the loan, the
- 27 amount of unexpended or unencumbered bond proceeds shall be disposed of as
- 28 provided in § 8-129 of the State Finance and Procurement Article.
- 29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 30 effect June 1, 2006.
