A BILL ENTITLED

1 AN ACT concerning

2 **Dorchester County Board of Education - Commencement of Member's Term**
3 **of Office Following Election**

4 FOR the purpose of altering the date of the commencement of the term of office of a
5 member of the Dorchester County Board of Education following the member's
6 election; and generally relating to the commencement of the term of office of a
7 member of the Dorchester County Board of Education.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Education**

16 3-5A-01.

17 (a) The Dorchester County Board consists of:

18 (1) Five voting members, elected in accordance with subsection (b) of this
19 section; and

20 (2) One nonvoting student member from each public high school in the
21 county.

22 (b) (1) The elected members of the County Board shall be elected at the
23 general election.

24 (2) One member shall be elected from each of the five councilmanic
25 districts only by the voters of that councilmanic district.

1 (c) (1) A member elected from a councilmanic district shall be a resident of
2 the district.

3 (2) A member elected or appointed from a councilmanic district who no
4 longer resides in the district may not continue as a member of the County Board.

5 (d) (1) Each voting member serves for a term of 4 years beginning [on
6 January 1] AT NOON ON THE FIRST MONDAY IN DECEMBER after the member's
7 election and until a successor is elected and qualifies.

8 (2) A voting member may not serve for more than three consecutive
9 terms.

10 (e) The terms of the voting members are staggered as follows:

11 (1) One member elected from each of the councilmanic districts 1, 3, and
12 5 at the 2004 general election, and every 4 years thereafter; and

13 (2) One member elected from each of the councilmanic districts 2 and 4
14 at the 2006 general election, and every 4 years thereafter.

15 (f) (1) The County Council shall appoint a new member to fill any vacancy
16 on the County Board for the remainder of that term and until a successor is elected
17 and qualifies.

18 (2) A resident of the district in which a vacancy exists may apply for
19 appointment by the County Council to fill the vacancy.

20 (3) The County Council shall adopt rules governing the procedure
21 through which an individual may apply to fill a vacancy on the County Board.

22 (g) (1) Each student member shall:

23 (i) Be a twelfth grade student in the Dorchester County public
24 school system elected by the high school students of the public school that the student
25 attends, in accordance with procedures established by the school system;

26 (ii) Serve for 1 year beginning on July 1 after the election of the
27 member;

28 (iii) Be a nonvoting member; and

29 (iv) Advise the Board on the interests of students.

30 (2) Unless invited to attend by an affirmative vote of a majority of the
31 County Board, the student members may not attend an executive session.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
33 October 1, 2006.
