- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:
- 22 Article Real Property

- 24 (A) THIS SECTION ONLY APPLIES TO A DEVELOPMENT THAT CONTAINS AT
- 25 LEAST 13,000 ACRES OF LAND AND HAS A POPULATION OF AT LEAST 80,000.
- 26 (B) NOTWITHSTANDING ANY PROVISION OF LAW OR CONTRACT, A PARCEL OF
- 27 LAND LOCATED IN THE NEW TOWN ZONING DISTRICT AND RECORDED IN THE LAND
- 28 RECORDS OF HOWARD COUNTY THAT IS NOT PART OF THE VILLAGE OR TOWN

- 1 CENTER IN WHICH THE LAND IS LOCATED MAY BE CONSOLIDATED INTO THE
- 2 VILLAGE OR TOWN CENTER IF:
- 3 (1) THE OWNER OR DEVELOPER OF THE LAND MAKES AN APPLICATION
- 4 FOR CONSOLIDATION TO THE VILLAGE OR TOWN CENTER COMMUNITY
- 5 ASSOCIATION; AND
- 6 (2) THE HOWARD RESEARCH AND DEVELOPMENT CORPORATION OR ITS
- 7 SUCCESSOR, THE COLUMBIA ASSOCIATION OR ITS SUCCESSOR, AND THE VILLAGE OR
- 8 TOWN CENTER COMMUNITY ASSOCIATION APPROVE THE CONSOLIDATION.
- 9 (C) AN INSTRUMENT THAT CONSOLIDATES A PARCEL OF LAND INTO THE
- 10 VILLAGE OR TOWN CENTER IN WHICH THE LAND IS LOCATED SHALL BE EXECUTED
- 11 AND FILED FOR RECORDATION IN THE LAND RECORDS OF HOWARD COUNTY.
- 12 (D) A PARCEL OF LAND THAT IS CONSOLIDATED INTO A VILLAGE OR TOWN
- 13 CENTER IN ACCORDANCE WITH THIS SECTION SHALL BE SUBJECT TO THE
- 14 RECORDED COVENANTS AND RESTRICTIONS OF THE VILLAGE OR TOWN CENTER IN
- 15 WHICH THE PARCEL OF LAND IS LOCATED.
- 16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
- 17 measure, is necessary for the immediate preservation of the public health or safety,
- 18 has been passed by a yea and nay vote supported by three-fifths of all the members
- 19 elected to each of the two Houses of the General Assembly, and shall take effect from
- 20 the date it is enacted.
