15 16 1	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

19 20 1	(a) (1) This section applies to any person charged with a violation of the Maryland Vehicle Law for exceeding, as to any vehicle or combination of vehicles:
21	(i) The maximum registered weight limit for which the vehicle or

12 signs is allowed and only weight in excess of this tolerance is a violation provided 13 that:

14 (1) An overall gross weight may not exceed 80,000 pounds, including any 15 enforcement or statutory tolerances; or

16 (2) The vehicle is being operated under a valid permit for gross weight in 17 excess of 80,000 pounds.

18 (c) [The] SUBJECT TO SUBSECTION (D) OF THIS SECTION, THE following fines,

19 in addition to court costs, are applicable to weight violations over the registered

20 weight limit, statutory weight limit, or weight limit imposed by signs, and for weight

21 violations that occur on any highway of this State, including interstate highways:

(1) 1 cent for each pound for the first 1,000 pounds of weight over anyallowable weight;

11(5)(6)80 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT12OVER 20,000 POUNDS.

13 [(d)] (E) Notwithstanding any other provision of law, on conviction for a 14 violation, no fine may be suspended or reduced. However, in computing the fine, a 15 credit for any excess weight caused by an accumulation of cinders, snow, or ice shall 16 be given.

17 [(e)] (F) (1) If the vehicle being operated at the time the offense is
18 committed is registered outside of this State, or if the person responsible for the
19 violation or the person operating the vehicle is a nonresident of this State, further
20 proceedings shall be had as to the person under Title 26 of this article or the vehicle

21 shall be impounded until the fine is paid or acceptable collateral posted.

22 (2) The impounding of the vehicle does not include the cargo, and the 23 cargo may not be held.

24 (3) If, after 90 days from the date the vehicle was impounded, the fine 25 has not been paid or acceptable collateral posted, the vehicle may be sold at public 26 auction under the jurisdiction of the court to satisfy the fine, accrued interest, and 27 costs.

28 [(f)] (G) The provisions of this section do not apply to an "emergency vehicle", 29 as defined in § 11-118 of this article, when responding to an emergency.

30 SECTION 2. AND BE IT FURTHER ENACTED, That the Department of

31 Transportation shall report to the Senate Judicial Proceedings Committee and the

32 House Environmental Matters Committee on or before December 1, 2007, on:

33 (1) the number of vehicles fined for weight violations occurring on the

34 Chesapeake Bay Bridge or its appurtenant approaches between October 1, 2005 and
