A BILL ENTITLED

1 AN ACT concerning

2 **Education - Geographic Cost of Education Index - Funding**

3 FOR the purpose of requiring the State to provide certain grants to certain county
4 boards of education to reflect regional differences in the cost of education that
5 are due to factors outside the control of local jurisdictions; providing for the
6 manner of calculation and distribution of certain grants in certain fiscal years;
7 and generally relating to the funding of a geographic cost of education index in
8 the Bridge to Excellence in Public Schools Act.

9 BY repealing and reenacting, with amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Education**

18 (f) (1) In this subsection, "GCEI adjustment" means the foundation
19 program for each county multiplied by:

- 20 (i) 0.000 in Allegany;
- 21 (ii) 0.018 in Anne Arundel;
- 22 (iii) 0.042 in Baltimore City;
- 23 (iv) 0.008 in Baltimore;

- 1 (v) 0.021 in Calvert;
- 2 (vi) 0.000 in Caroline;
- 3 (vii) 0.014 in Carroll;
- 4 (viii) 0.000 in Cecil;
- 5 (ix) 0.020 in Charles;
- 6 (x) 0.000 in Dorchester;
- 7 (xi) 0.024 in Frederick;
- 8 (xii) 0.000 in Garrett;
- 9 (xiii) 0.000 in Harford;
- 10 (xiv) 0.015 in Howard;
- 11 (xv) 0.010 in Kent;
- 12 (xvi) 0.034 in Montgomery;
- 13 (xvii) 0.048 in Prince George's;
- 14 (xviii) 0.011 in Queen Anne's;
- 15 (xix) 0.002 in St. Mary's;
- 16 (xx) 0.000 in Somerset;
- 17 (xxi) 0.000 in Talbot;
- 18 (xxii) 0.000 in Washington;
- 19 (xxiii) 0.000 in Wicomico; and
- 20 (xxiv) 0.000 in Worcester.

21 (2) [To the extent funds are provided in the State budget for the grants
22 under this subsection,] EACH YEAR, in addition to the State share of the foundation
23 program, each county board [may] SHALL receive a grant to reflect regional
24 differences in the cost of education that are due to factors outside of the control of the
25 local jurisdiction.

26 (3) [Subject to paragraph (4) of this subsection, the] THE amount of the
27 grant to each county board under this subsection shall equal the GCEI adjustment for
28 the county board multiplied times:

- 29 (i) [0.50 in fiscal year 2006;

- 1 (ii) 0.62 in fiscal year 2007;
- 2 [(iii) (II) 0.74 in fiscal year 2008;
- 3 [(iv) (III) 0.86 in fiscal year 2009; and
- 4 [(v) (IV) 1.00 in fiscal year 2010 and each fiscal year thereafter.

5 [(4) For any fiscal year, if sufficient funds are not provided in the State
 6 budget to fully fund the grants provided under this subsection, the grant to each
 7 county board under this subsection shall equal the amount determined under
 8 paragraph (3) of this subsection multiplied by a fraction:

9 (i) The numerator of which is the amount provided in the State
 10 budget to fund the grants; and

11 (ii) The denominator of which is the sum of the amounts calculated
 12 under paragraph (3) of this subsection for all the county boards.]

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 14 June 1, 2006.
