2 Public Institutions of Higher Education - Textbook Fairness Act

- 3 FOR the purpose of requiring the governing board of a public institution of higher
- 4 education to notify students of the textbooks assigned for certain courses on the

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (A) (1) THE GOVERNING BOARD OF A PUBLIC INSTITUTION OF HIGHER
- 20 EDUCATION SHALL NOTIFY STUDENTS OF THE TEXTBOOKS ASSIGNED FOR EACH
- 21 COURSE OFFERED AT THE INSTITUTION BY LISTING EACH ASSIGNED TEXTBOOK ON
- 22 THE WEBSITE OF THE INSTITUTION WHEN THE COURSE INSTRUCTOR OR ACADEMIC
- 23 DEPARTMENT OFFERING THE COURSE IDENTIFIES THE TEXTBOOK FOR ORDER AND
- 24 SUBSEQUENT STUDENT PURCHASE.
- 25 (2) THE NOTIFICATION SHALL INCLUDE THE INTERNATIONAL
- 26 STANDARD BOOK NUMBER (ISBN) FOR EACH TEXTBOOK.

- 9 SAMPLE COPY, INSTRUCTOR'S COPY, AND INSTRUCTIONAL MATERIAL; AND
- 10 (II) ROYALTIES OR OTHER COMPENSATION FROM THE SALE OF A
- 11 TEXTBOOK THAT INCLUDES THE WRITING OR WORK OF THE EMPLOYEE.

- 13 July 1, 2006.
