- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, That the Laws of Maryland read as follows:
- 12 Article Criminal Law
- 13 6-202.
- 14 (a) A person may not break and enter the dwelling of another with the intent
- 15 to commit theft or a crime of violence.
- 16 (b) A person who violates this section is guilty of the felony of burglary in the
- 17 first degree and on conviction is subject to imprisonment not exceeding 20 years OR A
- 18 FINE NOT EXCEEDING \$20,000 OR BOTH.

- 2 (a) A person may not break and enter the storehouse of another with the 3 intent to commit theft, a crime of violence, or arson in the second degree.
- 4 (b) A person may not break and enter the storehouse of another with the 5 intent to steal, take, or carry away a firearm.
- 6 (c) A person who violates this section is guilty of the felony of burglary in the 7 second degree and on conviction is subject to:
- 8 (1) for a violation of subsection (a) of this section, imprisonment not 9 exceeding 15 years OR A FINE NOT EXCEEDING \$15,000 OR BOTH; and
- 10 (2) for a violation of subsection (b) of this section, imprisonment not 11 exceeding 20 years or a fine not exceeding [\$10,000] \$20,000 or both.

- 13 (a) A person may not break and enter the dwelling of another with the intent 14 to commit a crime.
- 15 (b) A person who violates this section is guilty of the felony of burglary in the 16 third degree and on conviction is subject to imprisonment not exceeding 10 years OR 17 A FINE NOT EXCEEDING \$10,000 OR BOTH.

- 19 (a) A person may not break and enter the dwelling of another.
- 20 (b) A person may not break and enter the storehouse of another.
- 21 (c) A person, with the intent to commit theft, may not be in or on:
- 22 (1) the dwelling or storehouse of another; or
- 23 a yard, garden, or other area belonging to the dwelling or storehouse 24 of another.
- 25 (d) A person may not possess a burglar's tool with the intent to use or allow 26 the use of the burglar's tool in the commission of a violation of this subtitle.
- 27 (e) A person who violates this section is guilty of the misdemeanor of burglary
- 28 in the fourth degree and on conviction is subject to imprisonment not exceeding 3
- 29 years OR A FINE NOT EXCEEDING \$3,000 OR BOTH.
- 30 (f) A person who is convicted of violating § 7-104 of this article may not also
- 31 be convicted of violating subsection (c) of this section based on the act establishing the
- 32 violation of § 7-104 of this article.

- 2 (a) A person may not possess a burglar's tool with the intent to use or allow 3 the use of the burglar's tool in the commission of a crime involving the breaking and
- 4 entering of a motor vehicle.
- 5 (b) A person may not be in or on the motor vehicle of another with the intent 6 to commit theft of the motor vehicle or property that is in the motor vehicle.
- 7 (c) A person who violates this section is guilty of a misdemeanor, shall be
- 8 considered a rogue and vagabond, and on conviction is subject to imprisonment not
- 9 exceeding 3 years OR A FINE NOT EXCEEDING \$3,000 OR BOTH.
- 10 6-207.
- 11 (a) A person may not open or attempt to open a vault, safe, or other secure
- 12 repository by the use of a destructive device, as defined in § 4-501 of this article,
- 13 while committing burglary in the first, second, or third degree.
- 14 (b) A person who violates this section is guilty of the felony of burglary with
- 15 destructive device and on conviction is subject to imprisonment not exceeding 20
- 16 years OR A FINE NOT EXCEEDING \$20,000 OR BOTH.
- 17 (c) A sentence imposed for a violation of this section may be separate from and
- 18 consecutive to or concurrent with a sentence for another crime based on the act
- 19 establishing the violation of this section.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 October 1, 2006.
