7 responsible for the maintenance of the street lighting equipment and may

8 contract with an outside entity for the maintenance of the street lighting

9 equipment; requiring a person that controls the right to use space on certain

10 poles, lamp posts, or other mounting surfaces to allow a certain local

11 government to assume the rights and obligations of an electric company under

12 certain circumstances; prohibiting a local government from restricting or

13 prohibiting universal access for electricity or any other service under certain

14 circumstances; providing that certain provisions of law regarding high voltage

15 lines do not apply to the maintenance of street lighting equipment under certain

4 (A) IN THIS SECTION, "ELECTRIC COMPANY" HAS THE SAME MEANING AS 5 PROVIDED IN § 1-101 OF THE PUBLIC UTILITY COMPANIES ARTICLE.

6 (B) ON WRITTEN REQUEST BY A LOCAL GOVERNMENT, AN ELECTRIC
7 COMPANY SHALL SELL TO THE LOCAL GOVERNMENT SOME OR ALL OF THE ELECTRIC
8 COMPANY'S EXISTING STREET LIGHTING EQUIPMENT THAT IS LOCATED WITHIN THE
9 LOCAL JURISDICTION.

(C) IF THE LOCAL GOVERNMENT PURCHASES STREET LIGHTING EQUIPMENT
 FROM AN ELECTRIC COMPANY, THE LOCAL GOVERNMENT SHALL PAY TO THE
 ELECTRIC COMPANY THE FAIR MARKET VALUE OF THE STREET LIGHTING
 EQUIPMENT.

(D) A LOCAL GOVERNMENT THAT PURCHASES THE STREET LIGHTING
EQUIPMENT IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION SHALL BE
RESPONSIBLE FOR THE MAINTENANCE OF THE STREET LIGHTING EQUIPMENT AND
MAY CONTRACT WITH AN OUTSIDE ENTITY FOR THE MAINTENANCE OF THE STREET
LIGHTING EQUIPMENT.

(E) (1) ANY PERSON WHO CONTROLS THE RIGHT TO USE SPACE ON ANY
POLE, LAMP POST, OR OTHER MOUNTING SURFACE PREVIOUSLY USED IN THE LOCAL
JURISDICTION BY THE ELECTRIC COMPANY FOR STREET LIGHTING EQUIPMENT
SHALL ALLOW A LOCAL GOVERNMENT THAT HAS PURCHASED THE STREET
LIGHTING EQUIPMENT TO ASSUME THE RIGHTS AND OBLIGATIONS OF THE
ELECTRIC COMPANY WITH RESPECT TO THE SPACE FOR THE UNEXPIRED TERM OF
ANY LEASE OR OTHER AGREEMENT UNDER WHICH THE ELECTRIC COMPANY USED
THE SPACE.

(2) NOTWITHSTANDING PARAGRAPH (1) OF THIS SUBSECTION, THE
LOCAL GOVERNMENT MAY NOT RESTRICT OR PROHIBIT UNIVERSAL ACCESS FOR
ELECTRICITY OR ANY OTHER SERVICE BY ASSUMING THE RIGHTS AND OBLIGATIONS
OF AN ELECTRIC COMPANY AS TO SPACE ON ANY POLE, LAMP POST, OR OTHER
MOUNTING SURFACE USED FOR STREET LIGHTING EQUIPMENT.
