State Treasurer - Authorized Investments - Commercial Paper

3 FOR the purpose of altering the characteristics of certain commercial paper in which

- 4 the State Treasurer may invest or reinvest unexpended or surplus money;
- 5 authorizing investment or reinvestment in certain money market mutual funds
- 6 that may contain commercial paper holdings under certain circumstances;
- 7 requiring the State Treasurer to notify certain officials and the governing bodies

8 of certain local government units about the provisions of this Act; and generally

9 relating to authorized investments in commercial paper by the State Treasurer.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

19 (a) The Treasurer may invest or reinvest unexpended or surplus money over 20 which the Treasurer has custody in:

1 (1) an obligation for which the United States has pledged its faith and 2 credit for the payment of the principal and interest;

3 (2) an obligation that a federal agency or a federal instrumentality has 4 issued in accordance with an act of Congress;

1 (8) any investment portfolio created under the Maryland Local 2 Government Investment Pool defined under Article 95, § 22G of the Code that is 3 administered by the Office of the State Treasurer.

4 (b) The Treasurer may sell, redeem, or exchange an investment or 5 reinvestment made under this section in accordance with the limitations of this 6 section.

7 (c) Subject to § 2-1246 of the State Government Article, the Treasurer shall 8 report by January 3 of each year to the General Assembly on investment activities for 9 unexpended or surplus money over which the Treasurer has custody which have been 10 conducted during the previous fiscal year. At a minimum, the report shall specify for 11 General Fund investments and all other investments:

12 (1) the inventory of investments with maturity dates and the book and 13 market value as of June 30;

14 (2) the net income earned;

15 (3) the percentage share of each category of investment in the portfolio; 16 and

17 (4) any sale of investments prior to the maturity date.

18 (d) An investment made pursuant to this section shall be made:

(1) with the care, skill, prudence, and diligence under the circumstances
then prevailing that a prudent person acting in a like capacity and familiar with such
matters would use in the conduct of an enterprise of a like character and with like

22 aims;

(2) in a manner designed to reasonably match the anticipated cash flow
of the State so that sufficient funds are available to pay obligations upon proper
presentation for payment;

26 (3) so that a reasonable amount of cash or cash equivalents is available 27 for unanticipated cash needs;

28 (4) with due regard for minimizing risk while maximizing return;

29 (5) using competitive purchasing practices except when impractical;

30 (6) in accordance with a written investment policy;

31 (7) so that the securities and collateral may continue to be priced on a
32 market to market basis; and

(8) to avoid the enhancement of the personal financial position of the
 Treasurer or any employee of the Treasurer who has responsibilities for such

1 SECTION 2. AND BE IT FURTHER ENACTED, That prior to the effective date

2 of this Act, the Treasurer shall notify in writing the chief executive and governing

3 body of each local government unit required to have a local investment policy under

4 Article 95, Section 22F of the Code, to notify them of the changes contained in this Act

 $\,5\,$ and to provide them an opportunity to review, revise, and report any changes in the

6 local investment policies to the Treasurer, as appropriate.

7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2006.
