# A BILL ENTITLED

# 1 AN ACT concerning

# Creation of a State Debt - Maryland Consolidated Capital Bond Loan of 2006 and the Maryland Consolidated Capital Bond Loans of 1997, 1998, 1999, 2000, 2001, 2002, 2003, 2004, and 2005

FOR the purpose of authorizing the creation of a State Debt in the amount of Six 5 Hundred Sixty-Nine Million, Three Hundred Fifty-Eight Thousand Dollars 6 (\$669,358,000), the proceeds to be used for certain necessary building, 7 construction, demolition, planning, renovation, conversion, replacement, and 8 capital equipment purchases of this State, for acquiring certain real estate in 9 connection therewith, and for grants to certain subdivisions and other 10 organizations for certain development and improvement purposes, subject to the 11 requirement that certain grantees provide and expend certain matching funds 12 by certain dates; providing generally for the issuance and sale of bonds 13 evidencing the loan; authorizing certain unexpended appropriations in certain 14 prior capital budgets and bond loans to be expended for other public projects; 15 altering certain requirements for certain programs in certain prior capital 16 budgets and bond loans; providing that the authorizations of State Debt in 17 certain prior capital budgets and bond loans be reduced by certain amounts; 18 providing for certain additional information to be detailed about each project in 19 the capital program; repealing a requirement for a certain appropriation; and 20 generally relating to the financing of certain capital projects. 21

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 5 MARYLAND, That:

(1) The Board of Public Works may borrow money and incur 6 indebtedness on behalf of the State of Maryland through a State loan to be known as 7 the Maryland Consolidated Capital Bond Loan of 2006 in the total principal amount 8 of \$669,358,000. This loan shall be evidenced by the issuance, sale, and delivery of 9 10 State general obligation bonds authorized by a resolution of the Board of Public Works and issued, sold, and delivered in accordance with Sections 8-117 through 11 8-124 of the State Finance and Procurement Article and Article 31, Section 22 of the 12 13 Code.

14 (2) The bonds to evidence this loan or installments of this loan may be 15 sold as a single issue of bonds under Section 8–122 of the State Finance and 16 Procurement Article.

17 (3) The cash proceeds of the sale of the bonds shall be paid to the 18 Treasurer and first shall be applied to the payment of the expenses of issuing, selling, 19 and delivering the bonds, unless funds for this purpose are otherwise provided, and 20 then shall be credited on the books of the Comptroller and expended, on approval by 21 the Board of Public Works, for the following public purposes, including any applicable 22 architects' and engineers' fees:

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21 MARYLAND, That: 22

23 (1) The Board of Public Works may borrow money and incur indebtedness on behalf of the State of Maryland through a State loan to be known as 24 the Maryland Consolidated Capital Bond Loan of 2002 in the total principal amount 25 of [\$730,258,000] \$729,063,000. This loan shall be evidenced by the issuance, sale, 26 and delivery of State general obligation bonds authorized by a resolution of the Board 27 of Public Works and issued, sold, and delivered in accordance with Sections 8-117 28 through 8-124 of the State Finance and Procurement Article and Article 31, Section 29 22 of the Code. 30

9 SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly 10 declares that it is the public policy of this State to manage State general obligation 11 bond debt in a manner that will maintain Maryland's AAA bond rating. The General 12 Assembly further declares that legislative oversight, control, and review of all forms 13 of State obligations are essential to maintenance of the State's existing bond rating 14 and protection of the fiscal integrity of the State.

15 SECTION 4. AND BE IT FURTHER ENACTED, That, before work may 16 commence pursuant to any supplement to any appropriation contained in this Act, 17 satisfactory evidence must be given to the Board of Public Works that the project can 18 be completed with the aggregate of the funds in this Act and previously appropriated 19 for the stated purpose.

20 SECTION 5. AND BE IT FURTHER ENACTED, That, with the approval of 21 the Department of Budget and Management, any appropriation for construction 22 provided in this Act may be used to purchase capital equipment if the amount of the 23 appropriation exceeds the amount required for construction expenses, including 24 allowances for contingencies.

25 SECTION 6. AND BE IT FURTHER ENACTED, That, except as otherwise 26 provided in this Act, before a State agency or institution named in this Act as 27 responsible for an individual item may begin work with funds appropriated by this 28 Act, the agency or institution shall provide satisfactory evidence to the Board of 29 Public Works that the work described in the individual item can be completed with 30 the funds specified for that item.

SECTION 7. AND BE IT FURTHER ENACTED, That, with the approval of the Department of Budget and Management, any appropriation under the provisions of this Act that is in excess of the amount needed for a project may be credited to the Construction Contingency Fund under Section 3–609 of the State Finance and Procurement Article.

SECTION 8. AND BE IT FURTHER ENACTED, That, if federal funds are available to help accomplish any project identified in this Act, the State agency or institution responsible for the project shall make efforts through proper administrative procedures to obtain these federal funds. Before spending any funds appropriated by this Act, the agency or institution shall certify its efforts to the Board of Public Works and state the reason for any failure to obtain federal funds. If federal

funds are obtained, they shall be used to defray the costs of the project described in
 this Act and not to expand its scope.

# 3 SECTION 9. AND BE IT FURTHER ENACTED, That:

4 (a) for any appropriation for the planning of a State-owned project provided in 5 this Act, if a program required by Section 3–602(d) of the State Finance and 6 Procurement Article has not been submitted, the State agency or institution 7 responsible for the project shall submit a program to the Department of Budget and 8 Management for approval before funds may be expended from the appropriation; and

9 (b) for any appropriation for the construction of a State-owned project 10 provided in this Act, if preliminary plans and outline specifications required by 11 Section 3–602(f)(2)(i) of the State Finance and Procurement Article have not been 12 prepared, the State agency or institution responsible for the project shall submit 13 preliminary plans and outline specifications to the Department of Budget and 14 Management for approval before funds may be expended from the appropriation.

15 SECTION 10. AND BE IT FURTHER ENACTED, That no portion of the proceeds of a loan or any of the matching funds provided for a project funded under 16 17 this Act may be used for the furtherance of sectarian religious instruction, or in connection with the design, acquisition, construction, or equipping of any building 18 used or to be used as a place of sectarian religious worship or instruction, or in 19 20 connection with any program or department of divinity for any religious denomination. Upon the request of the Board of Public Works, a recipient of the 21 proceeds of a loan under this Act shall submit evidence satisfactory to the Board that 22 23 none of the proceeds of the loan or any matching funds has been or is being used for 24 a purpose prohibited by this Act.

25 SECTION 11. AND BE IT FURTHER ENACTED, That the Comptroller may 26 advance funds to any loan funds account established pursuant to a general obligation 27 bond loan enabling Act, for any expenditure authorized by that Act, provided that if 28 general obligation bonds have not been issued under the authority of that Act, the 29 next ensuing sale of general obligation bonds shall include the issuance of bonds 30 under the authority of that Act in an amount at least equivalent to the amount of the 31 funds so advanced.

32 SECTION 12. AND BE IT FURTHER ENACTED, That the net new debt to be 33 authorized by legislation in fiscal year 2007 may not exceed \$690,000,000, as 34 evidenced by the following:
