3 FOR the purpose of requiring the Department of Health and Mental Hygiene to

- 9 lighting to certain areas in a facility; requiring emergency electrical power to be provided to certain areas and equipment; requiring certain facilities to provide 10
- common areas or areas of refuge for certain patients under certain 11
- circumstances; requiring the Department to adopt certain regulations regarding 12

- common areas and areas of refuge; exempting certain facilities from the 14 requirements of this Act under certain circumstances; authorizing the
- 15 Department to grant a certain waiver to certain facilities under certain
- circumstances; requiring the Department to review certain waivers each year; 16
- providing for a delayed effective date; and generally relating to assisted living 17
- 18 program facilities and emergency electrical power generators.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 24

- 25 MARYLAND, That the Laws of Maryland read as follows:

EXCEPT AS PROVIDED IN SUBSECTIONS (G) AND (H) OF THIS SECTION, THE 28 (A) 29 DEPARTMENT SHALL REQUIRE THAT EACH ASSISTED LIVING PROGRAM FACILITY

THAT PROVIDES SERVICES TO 50 OR MORE INDIVIDUALS HAVE AN EMERGENCY
 ELECTRICAL POWER GENERATOR ON THE PREMISES.

3 (B) THE DEPARTMENT SHALL REQUIRE THAT EACH FACILITY PROVIDE 4 EMERGENCY ELECTRICAL POWER AS PROVIDED IN THIS SECTION.

5 (C) (1) THE EMERGENCY POWER SOURCE SHALL BE A GENERATING SET
6 AND PRIME MOVER LOCATED ON THE FACILITY PREMISES WITH AUTOMATIC
7 TRANSFER.

8 (2) AN EMERGENCY POWER SYSTEM SHALL MEET THE FOLLOWING 9 REQUIREMENTS:

(I) IN THE EVENT OF FAILURE OF THE NORMAL ELECTRIC
 SERVICE, THE EMERGENCY ELECTRICAL POWER SHALL BE ACTIVATED
 IMMEDIATELY;

13 (II) THE EMERGENCY GENERATOR SET SHALL COME TO FULL 14 SPEED AND LOAD ACCEPTANCE WITHIN 10 SECONDS; AND

15(III)THE EMERGENCY GENERATOR SHALL HAVE THE CAPABILITY16OF 48 HOURS OF OPERATION FROM FUEL STORED ON-SITE.

17(3)(I)THE EMERGENCY POWER SYSTEM SHALL BE TESTED ONE TIME18EACH MONTH.

19(II)THE EMERGENCY POWER SYSTEM TEST SHALL REQUIRE THAT20THE GENERATOR BE EXERCISED FOR A MINIMUM OF 30 MINUTES UNDER NORMAL21EMERGENCY FACILITY CONNECTED LOAD.

22 (III) THE TEST SHALL BE RECORDED IN A PERMANENT LOG BOOK23 MAINTAINED FOR THAT PURPOSE.

24 (D) THE EMERGENCY POWER SYSTEM SHALL PROVIDE LIGHTING IN THE 25 FOLLOWING AREAS OF THE FACILITY:

26 (1) AREAS OF EGRESS AND PROTECTION AS REQUIRED BY THE STATE
27 FIRE PREVENTION CODE AND LIFE SAFETY CODE 101 ADOPTED BY THE STATE FIRE
28 MARSHAL'S OFFICE;

- 29 (2) NURSES' STATION;
- 30 (3) DRUG DISTRIBUTION STATION OR UNIT DOSE STATION;
- 31 (4) AN AREA FOR EMERGENCY TELEPHONE USE;
- 32 (5) BOILER OR MECHANICAL ROOM;
- 33 (6) KITCHEN;
- 34 (7) EMERGENCY GENERATOR LOCATION AND SWITCH GEAR LOCATION;

- 1 (8) ELEVATOR, IF OPERABLE ON EMERGENCY POWER;
- 2 (9) AREAS WHERE LIFE SUPPORT EQUIPMENT IS USED;

3 (10) IF APPLICABLE, COMMON AREAS OR AREAS OF REFUGE; AND

4 (11) IF APPLICABLE, TOILET ROOMS OF COMMON AREAS OR AREAS OF

5 REFUGE.

- 6 (E) EMERGENCY ELECTRICAL POWER SHALL BE PROVIDED FOR THE 7 FOLLOWING:
- 8 (1) NURSES' CALL SYSTEM;
- 9 (2) AT LEAST ONE TELEPHONE IN ORDER TO MAKE AND RECEIVE CALLS;
- 10 (3) FIRE PUMP;
- 11 (4) SEWERAGE PUMP AND SUMP PUMP;
- 12 (5) IF REQUIRED FOR EVACUATION PURPOSES, AN ELEVATOR;
- 13 (6) IF NECESSARY, HEATING EQUIPMENT NEEDED TO MAINTAIN A
 14 MINIMUM TEMPERATURE OF 70 DEGREES FAHRENHEIT (24 DEGREES CELSIUS) IN
 15 ALL COMMON AREAS OR AREAS OF REFUGE;
- 16 (7) LIFE SUPPORT EQUIPMENT; AND
- 17 (8) NONFLAMMABLE MEDICAL GAS SYSTEMS.
- 18 (F) (1) IF THE EMERGENCY POWER SYSTEM DOES NOT PROVIDE HEAT TO
 19 ALL PATIENT ROOMS OR TOILET ROOMS IN THE EVENT OF A LOSS OF ELECTRICITY
 20 FROM THE MAIN SOURCE OF POWER, THE FACILITY SHALL PROVIDE COMMON AREAS
 21 OR AREAS OF REFUGE FOR ALL PATIENTS.
- (2) THE DEPARTMENT SHALL ADOPT REGULATIONS REGARDING THE
 REQUIREMENTS FOR DESIGNATING PARTS OF THE FACILITY AS COMMON AREAS OR

- (G) AN ASSISTED LIVING PROGRAM FACILITY SHALL BE EXEMPT FROM THE

 RESIDENTS THROUGH AN ENCLOSED CORRIDOR TO A BUILDING THAT IS EQUIPPED

- 30(H)(1)THE DEPARTMENT MAY GRANT A FACILITY A WAIVER FROM THE31REQUIREMENTS OF THIS SECTION IF THE FACILITY:

 33 REQUIREMENTS OF THIS SECTION WILL CREATE AN UNDUE FINANCIAL BURDEN ON

1(II)DISCLOSES TO THE RESIDENTS OF THE FACILITY THAT THE2FACILITY DOES NOT HAVE AN EMERGENCY ELECTRICAL POWER GENERATOR THAT3MEETS THE REQUIREMENTS OF THIS SECTION.

4 (2) THE DEPARTMENT SHALL EVALUATE A WAIVER GRANTED UNDER 5 THIS SUBSECTION EACH YEAR.
