6 certified medication technicians; authorizing the Rehabilitation Committee in
7 the Board to provide for the rehabilitation of or provide assistance to certain
8 medication technicians, electrologists, and certain applicants; ~~altering the term~~

33 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 34 MARYLAND, That the Laws of Maryland read as follows:

36 8-205.

37 (a) In addition to the powers and duties set forth elsewhere in this title, the
 38 Board has the following powers and duties:

- 1 (1) To adopt rules and regulations to carry out the provisions of this title;
- 2 (2) To set standards for the practice of registered nursing, [and] licensed
3 practical nursing, CERTIFIED NURSING ASSISTANTS, AND CERTIFIED MEDICATION
4 TECHNICIANS;
- 5 (3) To adopt rules and regulations for the performance of delegated
6 medical functions which are recognized jointly by the State Board of Physicians and
7 the State Board of Nursing, under § 14-306(d) of this article;
- 8 (4) To adopt rules and regulations for the performance of additional
9 nursing acts that:
- 10 (i) May be performed under any condition authorized by the Board,
11 including emergencies; and
- 12 (ii) Require education and clinical experience;
- 13 (5) To adopt rules and regulations for registered nurses to perform
14 independent nursing functions that:
- 15 (i) Require formal education and clinical experience; and
- 16 (ii) May be performed under any condition authorized by the Board,
17 including emergencies;
- 18 (6) To adopt rules and regulations for licensed practical nurses to
19 perform additional acts in the practice of registered nursing that:
- 20 (i) Require formal education and clinical experience;
- 21 (ii) May be performed under any condition authorized by the Board,
22 including emergencies; and
- 23 (iii) Are recognized by the Nursing Board as proper for licensed
24 practical nurses to perform;
- 25 (7) To keep a record of its proceedings;
- 26 (8) To submit an annual report to the Governor and Secretary;
- 27 (9) To enforce the employment record requirements of this title;
- 28 (10) To keep separate lists, which lists are open to reasonable public
29 inspection, of all:
- 30 (i) Registered nurses licensed under this title;
- 31 (ii) Licensed practical nurses licensed under this title;
- 32 (iii) Nurse midwives certified under this title;

- 1 (iv) Nurse practitioners certified under this title; and
- 2 (v) Other licensees with a nursing specialty that is certified under
3 this title;
- 4 (11) To collect any funds of the Board;
- 5 (12) To report any alleged violation of this title to the State's Attorney of
6 the county where the alleged violation occurred;
- 7 (13) In accordance with the State budget, to incur any necessary expense
8 for prosecution of an alleged violation of this title;
- 9 (14) On receipt of a written and signed complaint, including a referral
10 from the Commissioner of Labor and Industry, conduct an unannounced inspection of
11 the office of a nurse in independent practice, other than an office of a nurse in
12 independent practice in a hospital, related institution, freestanding medical facility,
13 or a freestanding birthing center, to determine compliance at that office with the
14 Centers for Disease Control's guidelines on universal precautions; and
- 15 (15) To maintain a nurse aide registry that complies with federal law.

17 (a) (1) In this section[,] THE FOLLOWING WORDS HAVE THE MEANINGS
18 INDICATED.

19 (2) "APPLICANT" MEANS AN INDIVIDUAL WHO HAS SUBMITTED AN
20 APPLICATION TO THE BOARD TO BE LICENSED AS A REGISTERED NURSE ~~OR~~
21 LICENSED PRACTICAL NURSE, ~~OR AN ELECTROLOGIST~~ OR TO BE CERTIFIED AS A
22 NURSING ASSISTANT OR MEDICATION TECHNICIAN IN THIS STATE.

23 (3) ["program"] "PROGRAM" means the rehabilitation program.

24 (b) (1) There is a Rehabilitation Committee in the Board.

25 (2) The Board may create 1 or more rehabilitation committees.

26 (j) In addition to the powers set forth elsewhere in this subtitle, the
27 Committee may:

28 (1) Evaluate those nurses, [or] nursing assistants, MEDICATION
29 TECHNICIANS, ELECTROLOGISTS, OR APPLICANTS who request participation in the
30 program according to the guidelines prescribed by the Board and consider the
31 recommendations for admission into the program;

32 (2) Review and designate those treatment facilities and services to which
33 nurses, [or] nursing assistants, MEDICATION TECHNICIANS, ELECTROLOGISTS, OR
34 APPLICANTS in the program may be referred;

1 (3) Receive and review information concerning a nurse, [or] nursing
2 assistant, MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT participating
3 in the program;

4 (4) Consider in the case of each nurse, [or] nursing assistant,
5 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT participating in a
6 program whether the nurse, [or] nursing assistant, MEDICATION TECHNICIAN,
7 ELECTROLOGIST, OR APPLICANT may with safety continue or resume the practice of
8 nursing OR DELEGATED NURSING FUNCTIONS OR ELECTROLOGY; and

9 (5) Have meetings as necessary to consider the requests of nurses, [or]
10 nursing assistants, MEDICATION TECHNICIANS, ELECTROLOGISTS, OR APPLICANTS
11 to participate in the program, and consider reports regarding nurses, [or] nursing
12 assistants, MEDICATION TECHNICIANS, ELECTROLOGISTS, OR APPLICANTS
13 participating in the program.

14 (k) In addition to the duties set forth elsewhere in this subtitle, the Committee
15 shall:

16 (1) Prepare reports to be submitted to the Board; and

17 (2) Set forth in writing for each nurse, [or] nursing assistant,
18 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT participating in the
19 program a rehabilitation program established for that nurse, [or] nursing assistant,
20 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT, including the
21 requirements for supervision and surveillance.

22 (l) The Committee shall inform each nurse, [or] nursing assistant,
23 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT who requests
24 participation in the program of:

25 (1) The procedures followed in the program;

26 (2) The rights and responsibilities of the nurse, [or] nursing assistant,
27 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT in the program; and

28 (3) The possible results of noncompliance with the program.

29 (m) (1) Each nurse, [or] nursing assistant, MEDICATION TECHNICIAN,
30 ELECTROLOGIST, OR APPLICANT who requests to participate in the program shall
31 agree to cooperate with the individual rehabilitation program designed by the
32 Committee.

33 (2) Any failure to comply with the provisions of a rehabilitation program
34 may result in termination of the nurse's, [or] nursing assistant's, MEDICATION
35 TECHNICIAN'S, ELECTROLOGIST'S, OR APPLICANT'S participation in the program.

36 (3) The Committee shall report the name and license number of a ~~nurse~~,
37 NURSE OR ELECTROLOGIST, [or] the name and certificate number of a nursing

1 assistant ~~OR,~~ OR MEDICATION TECHNICIAN, OR THE NAME OF AN APPLICANT who is
2 expelled from the program for failure to comply with the conditions of the program.

3 (4) (i) The program shall transfer to the Board all the records of any
4 nurse, [or] nursing assistant, MEDICATION TECHNICIAN, ELECTROLOGIST, OR
5 APPLICANT expelled from the program.

6 (ii) The Board may initiate disciplinary action based on the failure
7 of the nurse, [or] nursing assistant, MEDICATION TECHNICIAN, ELECTROLOGIST, OR
8 APPLICANT to comply with the conditions of the program in accordance with the
9 provisions of §§ 8-316 and 8-317 OR §§ 8-6B-18 AND 8-6B-19 of this title.

10 (n) After the Committee has determined that a nurse, [or] nursing assistant,
11 MEDICATION TECHNICIAN, ELECTROLOGIST, OR APPLICANT has been rehabilitated,
12 the Committee shall purge and destroy all records concerning a nurse's, [or] nursing
13 assistant's, MEDICATION TECHNICIAN'S, ELECTROLOGIST'S, OR APPLICANT'S
14 participation in the program.

15 (o) All Board and Committee records of a proceeding concerning the
16 rehabilitation of a nurse, [or] nursing assistant, MEDICATION TECHNICIAN,
17 ELECTROLOGIST, OR APPLICANT in the program are confidential and are not subject
18 to discovery or subpoena in any civil or criminal action.

19 (p) The Board shall provide for the representation of any person making
20 reports to the Committee or the Board under this section in any action for defamation
21 directly resulting from reports or information given to the Committee or the Board
22 regarding a nurse's, [or] nursing assistant's, MEDICATION TECHNICIAN'S,
23 ELECTROLOGIST'S, OR APPLICANT'S participation in the program.

25 (a) Except as otherwise provided in this title, an individual shall be licensed
26 by the Board before the individual may practice registered nursing in this State.

27 (b) Except as otherwise provided in this title, an individual shall be licensed
28 by the Board before the individual may practice licensed practical nursing in this
29 State.

30 (c) This section does not apply to:

31 (1) A student enrolled in an approved education program while
32 practicing registered nursing or licensed practical nursing in that program;

33 (2) An individual employed by the federal government to practice
34 registered nursing or licensed practical nursing while practicing within the scope of
35 that employment, if the individual is authorized by any state to practice registered
36 nursing or licensed practical nursing;

37 (3) An individual permitted to practice registered nursing or licensed
38 practical nursing under rules and regulations adopted by the Board, if the individual:

1 (i) Otherwise has qualified to practice registered nursing or
2 licensed practical nursing in any other state or country and is in this State
3 temporarily; or

4 (ii) Has an application for a license pending before the Board:

5 1. But has not taken the examination required under this
6 title; or

7 2. Has taken an examination under this title, but the results
8 of the examination are not yet known; and

9 (4) An individual who is assigned by the American Red Cross to a
10 disaster situation in this State to practice registered nursing or licensed practical
11 nursing, if the individual is licensed to practice registered nursing or licensed
12 practical nursing in another state.

13 (d) A registered nurse who has been granted multistate licensing privileges by
14 a party state to the Nurse Multistate Licensure Compact set forth in Subtitle 7A of
15 this title may practice registered nursing in the State.

16 (e) A licensed practical nurse who has been granted multistate licensing
17 privileges by a party state to the Nurse Multistate Licensure Compact set forth in
18 Subtitle 7A of this title may practice practical nursing in the State.

19 [(f) A nurse who has been granted multistate licensing privileges as described
20 in subsection (d) or (e) shall notify the Board, prior to commencing any nursing
21 employment in the State, of the identity and location of the nurse's prospective
22 employer.]

23 8-312.

24 (a) A license expires on the last day of the birth month of the licensee, unless
25 the license is renewed for a 1-year term as provided in this section.

26 (b) At least 1 month before the license expires, the Board shall send to the
27 licensee[, by first-class mail to the last known address of the licensee,] a renewal
28 notice [that states:

29 (1) The date on which the current license expires;

30 (2) The date by which the renewal application must be received by the
31 Board for the renewal to be issued and mailed before the license expires; and

32 (3) The amount of the renewal fee].

33 (c) Before a license expires, the licensee periodically may renew it for an
34 additional term, if the licensee:

35 (1) Otherwise is entitled to be licensed;

1 (2) Pays to the Board:

2 (i) A renewal fee set by the Board; or

3 (ii) A renewal fee that is set by the Board if the licensee certifies to
4 the Board that the licensee provides professional services only as a volunteer; and

5 (3) Submits to the Board:

6 (i) A renewal application on the form that the Board requires; and

7 (ii) Satisfactory evidence of completion of:

8 1. 1,000 hours of active nursing practice within the 5-year
9 period immediately preceding the date of renewal;

10 2. A course of instruction, commonly known as a refresher
11 course, approved by the Board; or

12 3. A preceptorship program provided by an employer and
13 approved by the Board.

14 (d) THE BOARD MAY GRANT A 30-DAY EXTENSION, BEYOND A LICENSE'S
15 EXPIRATION DATE, TO A LICENSEE SO THAT A THE LICENSEE MAY RENEW A THE
16 LICENSE BEFORE THE LICENSE IT EXPIRES.

17 (E) (1) Each licensee shall notify the Board in writing of any change in the
18 name or address of the licensee within 60 days after the change occurred.

19 (2) If a licensee fails to notify the Board within the time required under
20 this subsection, subject to the hearing provisions of § 8-317 of this subtitle, the Board
21 may impose an administrative penalty of \$100.

22 [(e)] (F) (1) The Board shall renew the license of each licensee who meets
23 the requirements of this section.

24 (2) A volunteer's license issued under paragraph (c)(2)(ii) of this section
25 shall be clearly designated as a volunteer's license.

22 (a) Except as otherwise provided in this subtitle, an individual shall be
 23 certified by the Board to practice as a nursing assistant or medication technician
 24 before the individual may practice as a nursing assistant or medication technician in
 25 the State.

26 (b) This subtitle does not apply to an individual who:

27 (1) Practices a health occupation that the individual is authorized to
 28 practice under this article;

29 (2) Provides for the gratuitous care of friends or family members;

30 (3) Performs nursing assistant tasks while a nursing student enrolled in
 31 an accredited nursing program and practicing under the direct supervision of
 32 qualified faculty or preceptors;

33 (4) Performs nursing assistant tasks as a student while:

34 (i) Enrolled in a Board-approved nursing assistant training
 35 program; OR

1 (ii) Practicing under the direct supervision of qualified faculty or
2 preceptors; [or

3 (iii) Practicing under the direct supervision of a licensed nurse while
4 working as a nursing assistant;]

5 (5) Performs medication technician tasks as a student while practicing
6 under the direct supervision of qualified faculty; or

7 (6) Works as a principal or school secretary, does not administer
8 medication as a routine part of the position, and has completed training by the
9 delegating nurse for the occasion where the individual may need to administer
10 medication in the absence of the nurse or medication technician.

11 (c) Nothing in this section shall preclude a registered nurse or licensed
12 practical nurse from delegating a nursing task to an unlicensed individual provided
13 that acceptance of delegated nursing tasks does not become a routine part of the
14 unlicensed individual's job duties.

15 [(d) Nothing in this subtitle may be construed as creating a scope of practice for
16 nursing assistants.]

18 (c) (1) An applicant for a certificate shall:

19 (i) Submit an application to the Board on the form that the Board
20 requires;

21 (ii) Provide evidence, as required by the Board, of successful
22 completion of [an]:

23 1. AN approved nursing assistant training program [or an];

24 2. AN approved course in medication administration; OR

25 3. A PORTION OF AN APPROVED NURSING EDUCATION

2 (a) A certificate expires on the 28th day of the birth month of the nursing
3 assistant or medication technician, unless the certificate is renewed for a 2-year term
4 as provided in this section.

5 (b) At least 3 months before the certificate expires, the Board shall send to the
6 nursing assistant or medication technician[, by first-class mail to the last known
7 address of the nursing assistant or medication technician,] a renewal notice that
8 states:

9 (1) The date on which the current certificate expires;

10 (2) The date by which the renewal application must be received by the
11 Board for the renewal to be issued and mailed before the certificate expires; and

12 (3) The amount of the renewal fee.

13 (c) Before a certificate expires, a nursing assistant periodically may renew it
14 for an additional term, if the certificate holder:

15 (1) Otherwise is entitled to be certified;

16 (2) Submits to the Board a renewal application on the form that the
17 Board requires;

18 (3) Pays to the Board a renewal fee set by the Board; and

19 (4) Provides satisfactory evidence of completion of:

20 (i) 16 hours of active nursing assistant practice within the 2-year
21 period immediately preceding the date of renewal; or

22 (ii) An approved nursing assistant training program.

23 (d) In addition to the requirements in subsection (c)(1), (2), and (3) of this
24 section, a skilled nursing assistant shall:

25 (1) Provide satisfactory evidence of completion of 1,000 hours of practice
26 as a skilled nursing assistant within the individual's specific category of nursing
27 assistant, in the 2-year period preceding the date of renewal; and

28 (2) Successfully complete a Board-approved refresher course within the
29 individual's specific category of nursing assistant.

30 (e) Before a certificate expires, a medication technician periodically may
31 renew it for an additional term, if the certificate holder:

32 (1) Otherwise is entitled to be certified;

- 1 (2) Submits to the Board a renewal application on the form that the
2 Board requires;
- 3 (3) Pays to the Board a renewal fee set by the Board; and
- 4 (4) Every 2 years, provides satisfactory evidence of completion of a
5 Board-approved clinical refresher course.

14 required under this subsection, the Board may impose an administrative penalty of
15 \$25 on the certificate holder.

17 the General Fund of the State.

19 (a) Subject to the hearing provisions of § 8-317 of this title, the Board may
20 deny a certificate or issue a probationary certificate to any applicant, reprimand any
21 certificate holder, place any certificate holder on probation, or suspend or revoke the
22 certificate of a certificate holder, if the applicant or certificate holder:

23 (1) Fraudulently or deceptively obtains or attempts to obtain a
24 certificate for the applicant or for another;

25 (2) Fraudulently or deceptively uses a certificate;

26 (3) Is disciplined by a licensing, military, or disciplinary authority in this
27 State or in any other state or country or convicted or disciplined by a court in this
