1 AN ACT concerning

2 **Workers' Compensation - Evaluation of Permanent Impairments - Social**
3 **Workers**

4 FOR the purpose of authorizing certain licensed certified social workers-clinical to
5 perform an evaluation of only the mental or behavioral portion of a permanent
6 impairment in a workers' compensation case under certain circumstances;
7 requiring that the report of an evaluation be submitted to the Workers'
8 Compensation Commission in accordance with the regulations of the
9 Commission; and generally relating to the evaluation of a permanent
10 impairment under workers' compensation law.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
22 MARYLAND, That the Laws of Maryland read as follows:

Article - Health Occupations

2 19-101.

3 (k) "Practice clinical social work" means to practice social work utilizing the
4 specialized education, training, and experience required under § 19-302(e) of this
5 title.

6 (m) (1) "Practice social work" means to apply the theories, knowledge,
7 procedures, methods, or ethics derived from a formal educational program in social
8 work to restore or enhance social functioning of individuals, couples, families, groups,
9 organizations, or communities through:

- 10 (i) Assessment;
- 11 (ii) Formulating diagnostic impressions;
- 12 (iii) Planning;
- 13 (iv) Intervention;
- 14 (v) Evaluation of intervention plans;
- 15 (vi) Case management;
- 16 (vii) Information and referral;
- 17 (viii) Counseling that does not include diagnosis or treatment of
18 mental disorders;
- 19 (ix) Advocacy;
- 20 (x) Consultation;
- 21 (xi) Education;
- 22 (xii) Research;
- 23 (xiii) Community organization; or
- 24 (xiv) Development, implementation, and administration of policies,
25 programs, and activities.

26 (4) For an individual licensed as a certified social worker-clinical,
27 "practice social work" also includes:

- 28 (i) Supervision of other social workers;
- 29 (ii) Evaluation, diagnosis, and treatment of psychosocial conditions
30 and mental disorders as defined in § 10-101(f) of the Health - General Article; and

1 (iii) The provision of psychotherapy.

3 (a) To obtain a license, an applicant shall demonstrate to the satisfaction of
4 the Board that the applicant:

5 (1) Has submitted a complete written application in the form prescribed
6 by the Board;

7 (2) Is at least 18 years old;

8 (3) Is of good moral character;

9 (4) Except as otherwise provided in this title, has successfully passed an
10 examination or examinations prescribed by the Board pertinent to the license sought;
11 and

12 (5) Has paid all applicable fees specified by the Board relative to the
13 licensure process.

14 (e) To obtain a certified social worker-clinical license, an applicant shall:

15 (1) Meet the requirements of subsection (a) of this section;

16 (2) Have received a master's degree in social work and documentation of
17 clinical course work from a program accredited by the Council on Social Work
18 Education; and

19 (3) Provide in a form prescribed by the Board, documentation of having
20 completed 2 years as a licensee with supervised experience of at least 3,000 hours
21 after receiving the master's degree with a minimum of 144 hours of periodic
22 face-to-face supervision in the assessment, formulation of a diagnostic impression,
23 and treatment of mental disorders and other conditions and the provision of
24 psychotherapy under the terms and conditions that the Board determines by
25 regulation.

26 **Article - Labor and Employment**

27 9-721.

28 (a) Except as provided in subsection (c) of this section, a physician shall
29 evaluate a permanent impairment and report the evaluation to the Commission in
30 accordance with the regulations of the Commission.

31 (b) A medical evaluation of a permanent impairment shall include information
32 about:

33 (1) atrophy;

34 (2) pain;

1 (3) weakness; and

2 (4) loss of endurance, function, and range of motion.

3 (c) If a permanent impairment involves a behavioral or mental disorder, a
4 licensed psychologist, A LICENSED CERTIFIED SOCIAL WORKER-CLINICAL, or
5 qualified physician shall:

6 (1) perform an evaluation of only the mental or behavioral portion of the
7 permanent impairment; and

8 (2) report the evaluation to the Commission in accordance with the
9 regulations of the Commission.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2006.
