CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Caroline County - Board of License Commissioners - Salaries**

3 FOR the purpose of altering the annual salaries of the chairman, regular members,  
4 and alternate member of the Board of License Commissioners of Caroline  
5 County; providing that this Act does not apply to the salary or compensation of  
6 the incumbent chairman, regular members, and alternate member of the Board;  
7 and generally relating to the Board of License Commissioners of Caroline  
8 County.

9 BY repealing and reenacting, with amendments,  
10 Article 2B - Alcoholic Beverages  
11 Section 15-109(g)  
12 Annotated Code of Maryland  
13 (2005 Replacement Volume)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article 2B - Alcoholic Beverages**

17 15-109.

18 (g) In Caroline County:

19 (1) [The chairman shall receive an annual salary of \$1,750 and the two  
20 associate members shall each receive an annual salary of \$1,500. The substitute  
21 member of the Board shall receive \$50 for each day employed in the actual discharge  
22 of official duties.] THE MEMBERS OF THE BOARD OF LICENSE COMMISSIONERS

1 SHALL RECEIVE ANNUAL SALARIES AS DETERMINED BY THE COUNTY  
2 COMMISSIONERS, BUT NOT LESS THAN:

3 (I) \$3,000 FOR THE CHAIRMAN; AND

4 (II) \$2,500 FOR A REGULAR BOARD MEMBER.

5 (2) THE ALTERNATE MEMBER OF THE BOARD SHALL RECEIVE \$100 PER  
6 MEETING BUT NOT MORE THAN \$2,000 IN ANY 1-YEAR PERIOD.

7 [(2)] (3) The chairman, associate members and substitute member shall  
8 be reimbursed for expenses incurred in the performance of their duties in accordance  
9 with the Standard State Travel Regulations.

10 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §  
11 35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
12 the salary or compensation of the chairman, regular members, or alternate member of  
13 the Board of License Commissioners of Caroline County in office on the effective date  
14 of this Act, but the provisions of this Act concerning the salary or compensation of the  
15 chairman, regular members, or alternate member of the Board of License  
16 Commissioners of Caroline County shall take effect at the beginning of the next  
17 following term of office.

18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
19 July 1, 2006.
