- 15 (b) The Commission consists of the following members:
- 16 (1) three judges of the Court of Appeals, appointed by the Chief Judge of 17 the Court of Appeals;
- 18 (2) three members of the Senate of Maryland, appointed by the President 19 of the Senate;
- 20 (3) three members of the House of Delegates, appointed by the Speaker 21 of the House; and
- 22 (4) the following members, appointed by the Governor:
- 23 (i) one representative of the Maryland State Bar Association;
- 24 (ii) one representative of the Maryland Trial Lawyers Association;
- 25 and
- 26 (iii) one representative of the Maryland Defense Council, Inc.

- 1 (c) The Chief Judge shall designate the chair of the Commission. 2 (d) The Administrative Office of the Courts shall provide staff for the 3 Commission. 4 A member of the Commission: (e) 5 (1) may not receive compensation; but 6 is entitled to reimbursement for expenses under the Standard State 7 Travel Regulations, as provided in the State budget. 8 (f) The Commission shall: assess and evaluate the current pilot programs for electronic filing of 10 pleadings and papers approved by the Court of Appeals under Maryland Rule 16-307; 11 study other states' statutes and court rules on the electronic filing of 12 court documents and any model electronic filing rules; 13 recommend a statewide plan so that all State courts accept electronic 14 filing of documents by January 1, 2009; and 15 recommend legislation and changes to the Maryland Rules to 16 implement the recommendations of the Commission. 17 The Commission shall report its findings and recommendations to the 18 Governor, the Chief Judge of the Court of Appeals, and, in accordance with § 2-1246 19 of the State Government Article, the General Assembly on or before December 31, 20 2006.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 June 1, 2006. It shall remain effective for a period of 8 months and, at the end of
- 23 January 31, 2007, with no further action required by the General Assembly, this Act
- 24 shall be abrogated and of no further force and effect.
