3 FOR the purpose of increasing the compensation for the judges of the Orphans' Court

- 4 for Dorchester County to be an amount determined by the County Council of

- 20 (k) Each of the judges of the Court for Dorchester County shall receive an
- 21 annual salary in the amount of AS DETERMINED BY THE COUNTY COUNCIL, BUT NOT

3 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §

4 35 of the Maryland Constitution, this Act may not be construed to extend or apply to

5 the salary or compensation of the judges of the Orphans' Court for Dorchester County

6 in office on the effective date of this Act, but the provisions of this Act concerning the

7 salary or compensation of the judges of the Orphans' Court for Dorchester County

8 shall take effect at the beginning of the next following term of office.

9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2006.
