- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:
- 19 Article Transportation
- 20 7-309.
- 21 (A) IN THIS SECTION, "ADVISORY COUNCIL" MEANS THE BALTIMORE
- 22 METROPOLITAN TRANSIT DISTRICT ADVISORY COUNCIL.
- 23 (B) THERE IS A BALTIMORE METROPOLITAN TRANSIT DISTRICT ADVISORY
- 24 COUNCIL.
- 25 (C) THE ADVISORY COUNCIL CONSISTS OF 13 MEMBERS WHO ARE REGULAR
- **26 TRANSIT USERS AS FOLLOWS:**
- 27 (1) SIX RESIDENTS OF BALTIMORE CITY, APPOINTED BY THE MAYOR OF
- 28 BALTIMORE CITY;

- 1 (2) THREE RESIDENTS OF BALTIMORE COUNTY, APPOINTED BY THE 2 BALTIMORE COUNTY EXECUTIVE;
- 3 (3) TWO RESIDENTS OF ANNE ARUNDEL COUNTY, APPOINTED BY THE 4 ANNE ARUNDEL COUNTY EXECUTIVE;
- 5 (4) ONE RESIDENT OF HARFORD COUNTY, APPOINTED BY THE HARFORD 6 COUNTY EXECUTIVE; AND
- 7 (5) ONE RESIDENT OF HOWARD COUNTY, APPOINTED BY THE HOWARD 8 COUNTY EXECUTIVE.
- $9 \hspace{0.4cm} (D) \hspace{0.4cm} THE \hspace{0.1cm} ADVISORY \hspace{0.1cm} COUNCIL \hspace{0.1cm} SHALL \hspace{0.1cm} SELECT \hspace{0.1cm} A \hspace{0.1cm} CHAIR \hspace{0.1cm} FROM \hspace{0.1cm} AMONG \hspace{0.1cm} ITS \hspace{0.1cm} 10 \hspace{0.1cm} MEMBERS.$
- 11 (E) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE 12 TERM OF A MEMBER IS 2 YEARS.
- 13 (2) THE FIRST TERM FOR THE FOLLOWING MEMBERS IS 3 YEARS, AFTER 14 WHICH THE MEMBER OR THE MEMBER'S SUCCESSOR SHALL SERVE A 2-YEAR TERM:
- 15 (I) THREE OF THE MEMBERS FROM BALTIMORE CITY;
- 16 (II) ONE MEMBER EACH FROM BALTIMORE AND ANNE ARUNDEL
- 17 COUNTIES; AND
- 18 (III) THE MEMBER FROM HARFORD COUNTY.
- 19 (3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL A 20 SUCCESSOR IS APPOINTED AND QUALIFIES.
- 21 (4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES
- 22 ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND
- 23 QUALIFIES.
- 24 (F) (1) THE ADMINISTRATION SHALL PROVIDE STAFF AND RESOURCES FOR 25 THE ADVISORY COUNCIL.
- 26 (2) STATE AND LOCAL AGENCIES SHALL COMPLY WITH ANY
- 27 REASONABLE REQUEST FOR INFORMATION OR DOCUMENTATION MADE BY THE
- 28 ADVISORY COUNCIL IN THE COURSE OF FULFILLING ITS DUTIES.
- 29 (G) A MEMBER OF THE ADVISORY COUNCIL:
- 30 (1) MAY NOT RECEIVE COMPENSATION; BUT
- 31 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
- 32 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

- 1 (H) THE ADVISORY COUNCIL SHALL STUDY, INVESTIGATE, AND MONITOR, AND
- 2 MAKE RECOMMENDATIONS TO THE ADMINISTRATION WITH RESPECT TO, BUS AND
- $3\,$ RAIL TRANSIT IN THE BALTIMORE METROPOLITAN TRANSIT DISTRICT.
- 4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 5 effect July 1, 2006.
