A BILL ENTITLED

1 AN ACT concerning

2                           **State Retirement and Pension System - Military Service - Members and**  
3                           **Former Members**

4 FOR the purpose of providing that members or certain former members of a State  
5 system may apply for service credit in a State system for certain military  
6 service; prohibiting certain retirees from applying for service credit in a State  
7 system for certain military service; providing that the military service that  
8 members or certain former members receive is applied toward their retirement  
9 allowance using a certain accrual rate; and generally relating to members and  
10 former members of a State system receiving service credit for certain military  
11 service.

12 BY repealing and reenacting, with amendments,  
13 Article - State Personnel and Pensions  
14 Section 23-309(c) and 38-104  
15 Annotated Code of Maryland

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That the Laws of Maryland read as follows:

19                           **Article - State Personnel and Pensions**

20 23-309.

21       (c)       (1)       This subsection applies only to a member who is:

22                           (i)       subject to the contributory pension benefit under Subtitle 2,  
23 Part II of this title; and

24                           (ii)       entitled to eligibility service for military service credit granted  
25 under Title 38 of this article.

26       (2)       The Board of Trustees shall adjust a member's eligibility service for  
27 military service credit granted under Title 38 of this article as provided in this  
28 subsection.

1           [(3)   (i)    Except as provided in subparagraph (ii) of this paragraph, a  
2 member's eligibility service for military service credit shall be treated as creditable  
3 service on or after July 1, 1998.

4           (ii)    The Board of Trustees shall treat a member's military service  
5 credit as creditable service on or before June 30, 1998, if the member:

6                           1.       is entitled to credit for the military service under § 38-103  
7 of this article on account of the member's absence from employment while in military  
8 service on or before June 30, 1998; or

9                           2.       received credit for the military service under § 38-104 of  
10 this article on or before June 30, 1998, as reflected in the records of the State  
11 Retirement Agency.]

12 38-104.

13   (a)   (1)    THIS SECTION APPLIES TO AN INDIVIDUAL WHO IS:

14                           (I)     A MEMBER OF A STATE SYSTEM; OR

15                           (II)    A FORMER MEMBER OF A STATE SYSTEM WHO IS ELIGIBLE TO  
16 RECEIVE A BENEFIT UNDER § 29-302 OR § 29-303 OF THIS ARTICLE.

17           (2)    THIS SECTION DOES NOT APPLY TO A RETIREE OF A STATE SYSTEM.

18   (B)    Except as provided in subsection [(b)] (C) of this section, [a member of a  
19 State system] AN INDIVIDUAL DESCRIBED IN SUBSECTION (A) OF THIS SECTION, who  
20 has not met the conditions set forth in § 38-103(a)(2) through (4) of this subtitle, is  
21 entitled to receive service credit for military service only on the attainment of 10  
22 years of creditable service.

23   [(b)]   (C)    (1)    [A member of a State system] AN INDIVIDUAL DESCRIBED IN  
24 SUBSECTION (A) OF THIS SECTION may not receive credit for that military service if  
25 the [member] INDIVIDUAL receives credit for military service from another  
26 retirement system for which retirement benefits have been or will be received by the  
27 [member] INDIVIDUAL.

28           (2)    Paragraph (1) of this subsection does not apply to:

29                           (i)     credit for military service provided under:

30                                   1.       the Social Security Act;

31                                   2.       the National Railroad Retirement Act; or

32                                   3.       Title 3 or Title 10, Chapter 1223, §§ 12731 through 12737  
33 of the United States Code; or

34                           (ii)    disability payments from a pension or retirement system.

1                   (3)     (i)       Military service credit under this section may not exceed 5  
2 years.

3                               (ii)       Subject to subparagraph (i) of this paragraph, a member of the  
4 Maryland National Guard who has not been activated under Title 10 of the United  
5 States Code, shall receive service credit at the rate of 4 months for each full year of  
6 service with the Maryland National Guard, not to exceed a total of 36 months.

7     (D)       THE SERVICE CREDIT FOR MILITARY SERVICE THAT AN INDIVIDUAL  
8 RECEIVES UNDER THIS SECTION SHALL BE APPLIED TO THE INDIVIDUAL'S  
9 RETIREMENT ALLOWANCE USING THE ACCRUAL RATE IN EFFECT AT THE TIME THE  
10 INDIVIDUAL RETIRES FROM A STATE SYSTEM.

11     SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12 July 1, 2006.
