2 **Calvert County - County Officials - Salaries**

3 FOR the purpose of altering the salaries of the County Commissioners of Calvert
 4 County, Calvert County Treasurer, Sheriff of Calvert County, and Orphans'
 5 Court Judges for Calvert County; providing that this Act does not apply to the
 6 salary or compensation of the incumbent County Commissioners of Calvert
 7 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court
 8 Judges for Calvert County; and generally relating to the salaries of certain
 9 Calvert County officials.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
10 MARYLAND, That the Laws of Maryland read as follows:

11 **Article 5 - Calvert County**

13 (a) Five county commissioners comprise the Board of County Commissioners
14 of Calvert County.

15 (b) (1) The annual salary of the president of the board is:

16 (I) [\$37,500] \$41,500 for calendar year [2002] 2006;

17 (II) [\$38,500] \$42,500 for calendar year [2003] 2007;

18 (III) [\$39,500] \$43,500 for calendar year [2004] 2008; and

19 (IV) [\$40,500] \$44,500 for calendar year [2005] 2009 and each
20 subsequent calendar year.

21 (2) The annual salary of each of the associate members of the board is:

22 (I) [\$35,000] \$39,000 for calendar year [2002] 2006;

23 (II) [\$36,000] \$40,000 for calendar year [2003] 2007;

24 (III) [\$37,000] \$41,000 for calendar year [2004] 2008; and

25 (IV) [\$38,000] \$42,000 for calendar year [2005] 2009 and each
26 subsequent calendar year.

27 (c) Each commissioner may be reimbursed up to an annual total of \$2,000, for
28 any reasonable costs incurred by the commissioner in carrying out the functions of the
29 office.

3 (c) (1) The County Treasurer of Calvert County shall receive an annual
4 salary of:

5 (i) [\$44,000] \$46,875 for calendar year [2002] 2006;

6 (ii) [\$44,500] \$48,250 for calendar year [2003] 2007;

7 (iii) [\$45,000] \$49,625 for calendar year [2004] 2008; and

8 (iv) [\$45,500] \$51,000 for calendar year [2005] 2009 and each
9 subsequent calendar year.

12 (f) (1) The Sheriff of Calvert County shall receive an annual salary of:

13 (i) [\$57,000] \$78,000 for calendar year [2002] 2006;

14 (ii) [\$59,500] \$81,000 for calendar year [2003] 2007;

15 (iii) [\$62,000] \$84,000 for calendar year [2004] 2008; and

16 (iv) [\$64,500] \$87,000 for calendar year [2005] 2009 and each
17 subsequent calendar year.

Article - Estates and Trusts

20 (f) (1) Each of the judges of the Court for Calvert County shall receive as
21 annual compensation the sum of:

22 (i) [\$7,000] \$8,000 for calendar year [2002] 2006;

23 (ii) [\$7,250] \$8,250 for calendar year [2003] 2007;

24 (iii) [\$7,500] \$8,500 for calendar year [2004] 2008; and

25 (iv) [\$7,750] \$8,750 for calendar year [2005] 2009 and each
26 subsequent calendar year.

27 (2) The salary of the Chief Judge is:

28 (i) [\$7,200] \$8,200 for calendar year [2002] 2006;

- 1 (ii) [\$7,450] \$8,450 for calendar year [2003] 2007;
- 2 (iii) [\$7,700] \$8,700 for calendar year [2004] 2008; and
- 3 (iv) [\$7,950] \$8,950 for calendar year [2005] 2009 and each
4 subsequent calendar year.

5 (3) The County Commissioners may provide additional funds for
6 expenses for the judges.

7 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
8 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
9 the salary or compensation of the County Commissioners of Calvert County, Calvert
10 County Treasurer, Sheriff of Calvert County, or Orphans' Court Judges for Calvert
11 County in office on the effective date of this Act, but the provisions of this Act
12 concerning the salary or compensation of the County Commissioners of Calvert
13 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court
14 Judges for Calvert County shall take effect at the beginning of the next following term
15 of office.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2006.
