## A BILL ENTITLED

## 1 AN ACT concerning

## 2 Creation of a State Debt - Montgomery County - Our House Youth Home

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,500,000,
- 4 the proceeds to be used as a grant to the Board of Directors of Our House Youth
- 5 Home, Inc. for certain development or improvement purposes; providing for
- 6 disbursement of the loan proceeds, subject to a requirement that the grantee
- 7 provide and expend a matching fund; requiring the grantee to grant and convey
- 8 a certain easement to the Maryland Historical Trust; establishing a deadline for
- 9 the encumbrance or expenditure of the loan proceeds; and providing generally
- for the issuance and sale of bonds evidencing the loan.

## 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 12 MARYLAND, That:
- 13 (1) The Board of Public Works may borrow money and incur indebtedness on
- 14 behalf of the State of Maryland through a State loan to be known as the Montgomery
- 15 County Our House Youth Home Loan of 2006 in a total principal amount equal to
- 16 the lesser of (i) \$1,500,000 or (ii) the amount of the matching fund provided in
- 17 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,
- 18 and delivery of State general obligation bonds authorized by a resolution of the Board
- 19 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 20 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 21 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 22 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 23 § 8-122 of the State Finance and Procurement Article.
- 24 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 25 and first shall be applied to the payment of the expenses of issuing, selling, and
- 26 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 27 shall be credited on the books of the Comptroller and expended, on approval by the
- 28 Board of Public Works, for the following public purposes, including any applicable
- 29 architects' and engineers' fees: as a grant to the Board of Directors of Our House
- 30 Youth Home, Inc. (referred to hereafter in this Act as "the grantee") for renovation
- 31 and capital equipping of Mellwood Farm located in Olney and to be used by the
- 32 grantee as the permanent home for a residential training facility.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years.
- 3 when due and until paid in full. The principal shall be discharged within 15 years
- 4 after the date of issuance of the bonds.
- 5 (5) Prior to the payment of any funds under the provisions of this Act for the
- 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 7 matching fund. No part of the grantee's matching fund may be provided, either
- 8 directly or indirectly, from funds of the State, whether appropriated or
- 9 unappropriated. No part of the fund may consist of real property, in kind
- 10 contributions, or funds expended prior to the effective date of this Act. In case of any
- 11 dispute as to the amount of the matching fund or what money or assets may qualify
- 12 as matching funds, the Board of Public Works shall determine the matter and the
- 13 Board's decision is final. The grantee has until June 1, 2008, to present evidence
- 14 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 15 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 16 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 17 amount of the matching fund shall be expended for the purposes provided in this Act.
- 18 Any amount of the loan in excess of the amount of the matching fund certified by the
- 19 Board of Public Works shall be canceled and be of no further effect.
- 20 (6) Prior to the issuance of the bonds, the grantee shall grant and convey
- 21 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 22 its interest:
- 23 (i) On the land or such portion of the land acceptable to the Trust;
- 24 and
- 25 (ii) On the exterior and interior, where appropriate, of the historic
- 26 structures.
- 27 (b) If the grantee or beneficiary of the grant holds a lease on the land
- 28 and structures, the Trust may accept an easement on the leasehold interest.
- 29 (c) The easement must be in form and substance acceptable to the Trust
- 30 and any liens or encumbrances against the land or the structures must be acceptable
- 31 to the Trust.
- 32 (7) The proceeds of the loan must be expended or encumbered by the Board of
- 33 Public Works for the purposes provided in this Act no later than June 1, 2013. If any
- 34 funds authorized by this Act remain unexpended or unencumbered after June 1,
- 35 2013, the amount of the unencumbered or unexpended authorization shall be
- 36 canceled and be of no further effect. If bonds have been issued for the loan, the
- 37 amount of unexpended or unencumbered bond proceeds shall be disposed of as
- 38 provided in § 8-129 of the State Finance and Procurement Article.
- 39 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 40 June 1, 2006.
