SENATE JOINT RESOLUTION

Compensation to Families of Military Service Members Who Gave Their Lives in the Service of Our Country

4 FOR the purpose of urging the President and the Congress of the United States to

5 compensate the families of military service members who gave their lives in the

6 service of our country; providing that a copy of this resolution be forwarded by

7 the Department of Legislative Services to certain individuals; and generally

8 relating to compensation to families of military service members who gave their

9 lives in the service of our country.

10 WHEREAS, A recently released study by the Rand Corporation found that the

11 civilian families who lost loved ones in the terrorist attacks of September 11, 2001,

12 received an average of \$3,100,000 in compensation, mostly from the government, and

13 that the families of firefighters and police officers killed as a result of the terrorist

14 attacks received an average of \$4,200,000; and

15 WHEREAS, The current death gratuity for survivors of military service

16 members killed in action is a lump sum payment of \$12,420, and the current monthly

 $17\,$ payment to surviving spouses who do not remarry is \$993 per month, plus \$247 per

18 child, with a slightly higher amount received per child by surviving children of

19 military service members who did not have a surviving spouse; and

20 WHEREAS, The sacrifices made by military service members who gave their

21 lives in Iraq, Afghanistan, and in other locations in service of our country deserve to

22 be honored by increasing the present compensation to the families of those military

23 service members; and

WHEREAS, The Congress of the United States is considering legislation that would increase the compensation to the families of military service members who gave their lives in the line of duty; now, therefore, be it

27 RESOLVED BY THE SENATE OF MARYLAND, That the Senate urges the

28 President and the Congress of the United States to adequately compensate the

29 families of military service members who gave their lives in the service of our country;
