Authorizing the creation of a State Debt in the amount of \$462,500, the proceeds to be used as a grant to the Board of Directors of the Fire Museum of Maryland, Inc. for the planning, design, construction, repair, renovation, reconstruction, and capital equipping of the Fire Museum of Maryland.				
7. Matching Fund Requirements				
This bill requires a matching fund of \$50,000 that may consist of real property, in-kind contributions, and funds expended prior to the effective date of the Act.

9. Description and Purpose of Grantee Organization (3000 characters maximum)				
<p>1.The Fire Museum of Maryland (FMM) displays and interprets the history of the fire service (fire fighting and medical) in the U.S. as seen through the eyes of Marylanders.</p> <p>2.The FMM teaches new generations about the sacrifice of fire fighters, technology development, and personal fire safety.</p> <p>3.The FMM averages 15,000 visitors per annum, including 5,600 school children, 90% of whom are from Baltimore County and Baltimore City.</p> <p>4.The FMM has the highest visitor rate of any museum in Baltimore County.</p> <p>5.The FMM is a 501(c)(3) governed by a Board of Directors; Founded in 1971; Owns the real estate and is debt-free; Began a fund-raising program in 2002: is supported mainly by admissions and donators both private and corporate.</p> <p>6.The FMM research archives and library are open by appointment.</p> <p>7.The collections of the FMM are the third largest in the world: very rich in Baltimore City history (from 1763) and horse-drawn period materials; and personal fire prevention and fire safety.</p>				

10. Description and Purpose of Project (3000 characters maximum)

This project is in four parts:

1. A new museum-quality lighting system is needed. The present one will be inoperable by 2007 due to new environmental laws. The new system will provide color-corrected general light as well as highlighting of special areas.
2. A new main building cooling and heating system is needed. There is no cooling at present. Summers are getting longer and hotter, so this new HVAC system will provide temperature stability year round for visitors and objects alike.
3. New roofs are required on every building. The old ones are coming to the end of their life span.
4. We wish to complete the Discovery Room used for children's exploration, seminars and meetings, by making it more energy efficient and installing an A.D.A. Rest Room.

The FMM is asking for State help in making these physical plant improvements that are critical for preservation and operation. The Museum is too new at fund raising to undertake such a massive program at this time.

28. Comments: (3000 characters maximum)		
<p>The Fire Museum of Maryland, located on I-695, north of Baltimore City and Towson, needs State Legislative support to provide four capital improvements because we can not do them for ourselves. Each of these improvements: lighting, HVAC system, roofs, and rest room, will have a huge impact on our visitors. During the last four years our fund raising efforts have been positive, increasing private and corporate donations by 226%, all of which is needed in operations. In 2006 it is anticipated that a full-time Development Director will be hired to help in raising the Museum's match for this Bond Bill.</p> <p>The Fire Museum is a treasure of fire fighting history for all people and the FMM tells it from a Maryland perspective. From the largest aerial ladder to the smallest flash light, the goal of the FMM is to have an impact on its visitors. Forty-three vehicles, thousands of photographs and hundreds of books make the story of fire safety within the community a very real experience. Since 1971 several hundred thousand visitors have learned about their heritage, and of their need for constant vigilance against fire.</p> <p>The Museum's Educator has built bridges with the schools in Baltimore City, County and contiguous counties, using their curricula to bring the young student together with history. It is here that visitors come face to face with the real thing: a classroom beyond the book. Some tours opt to go to a fire station after they leave the FMM to see the newest equipment and meet a fire fighter.</p> <p>Improvements to the Fire Museum of Maryland, Maryland's only fire museum that is open regularly, will result in increased attendance and better preservation of the collections. Fire fighting is an age-old part of human existence. Its history is compelling, and lessons in fire safety continue to be essential in the prevention of tragic accidents.</p>
