The Cal Ripken, Sr. Foundation works to create baseball and softball experiences that develop character and give disadvantaged youth opportunities to succeed.				
10. Description and Purpose of Project (3000 characters maximum)				
The capital project is building Cal Sr.'s Yard, an \$8.6 million youth-sized replica of Camden Yards designed to offer disadvantaged youth skill building in baseball and softball, while instilling positive messages about character development, strong work ethic, personal responsibility, teamwork and good sportsmanship -- those important traits for which Cal Ripken, Jr. is so well known. Funding is requested for Phase III, the final phase, to add structural necessities, expanded seating capacity from 300 to 3,500, bullpen area, scoreboard, and outfield concession/family picnic area

Phase I of Cal Sr.'s Yard included the playing field; Phase II included the stadium superstructure, lights, a seating bowl for 600, concourse with space for concessions and bathrooms, and a press box. Phase III will include extension of the seating bowl to accommodate 3,500 fans, bullpen area, retaining wall, electronic scoreboard, and an outfield concession/family picnic area. Cal Sr.'s Yard is the centerpiece of a youth baseball complex that draws thousands of players, parents and fans from Maryland, the region, the US and around the world. Estimated economic impact on Harford County is \$2 million, while the overall State impact is \$3 million.
