FISCAL AND POLICY NOTE

House Bill 1545 Ways and Means (Delegates Marriott and Gutierrez)

Education - Kindergarten Plus Program for "High-Poverty Schools"

This bill establishes a Kindergarten Plus Program at every public elementary school in which 85% or more of the students are eligible for free and reduced price meals. The stated purpose of the program is to provide increased time in kindergarten to students attending high-poverty schools in order to narrow the achievement gap and increase the cognitive skills and test scores of disadvantaged students.

Fiscal Summary

State Effect: General fund expenditures would increase by an estimated \$64,400 in FY 2007 to prepare for the implementation of the Kindergarten Plus Program. General fund expenditures would increase by an estimated \$8.4 million in FY 2008 when the first year of grants for the program would be awarded. Future year expenditure estimates reflect regular salary increases and inflation. Revenues would not be affected.

Local Effect: Local school revenues from State aid would increase by an estimated \$8.3 million in FY 2008 to enable school systems to provide Kindergarten Plus Programs.

Small Business Effect: None.

Analysis

Bill Summary: The bill provides that the Kindergarten Plus Program may begin at least two months earlier and may end up to two months later than the regular kindergarten program. The Maryland State Department of Education (MSDE) must develop applications for funding and must provide additional professional development for instructional staff participating in the program. Local boards of education participating in the program must demonstrate that their programs meet the standards established by MSDE. The boards must employ only qualified staff and must pay kindergarten plus personnel at rates comparable to staff in the regular kindergarten programs.

In order to assess the effectiveness of the Kindergarten Plus Program, MSDE must establish reporting and evaluation requirements for each participating school. Local boards of education must evaluate the students participating in the program at the beginning of the program and measure their progress through the use of standardized tests conducted in kindergarten and first grade. MSDE must submit an annual report on the efficacy of the program.

The bill requires the Governor to include funds for the Kindergarten Plus Program in the annual budget for MSDE. The funds provided for the program may include grants, donations, and private gifts received by the State.

Current Law: All local school systems are required to provide full-day kindergarten programs for all students by the 2007-2008 school year. Local boards of education have the authority to implement extended year programs for targeted student populations but they are not required to implement the programs.

Background: In the 2005-2006 school year, 81% of Maryland kindergartners are attending full-day programs and 11 school systems are providing full-day programs for all kindergarten students. According to data from MSDE, only Carroll County provides full-day kindergarten for less than half of its kindergarten students. **Exhibit 1** shows the total number of kindergarten students, the number of kindergarten students in full-day programs, and the percentage of kindergarten students attending full-day programs in each school system.



The bill states that the purpose of the Kindergarten Plus Program is to narrow the achievement gap, and the bill requires the program to be implemented in schools with

high percentages of students eligible for free and reduced price meals. Maryland School Assessment results for students eligible for subsidized meals and those who are not eligible for subsidized meals are shown in **Exhibit 2**. The exhibit reveals that lower percentages of disadvantaged students score at the proficient or advanced levels on the statewide tests.



State Expenditures: General fund expenditures could increase by an estimated \$64,383 in fiscal 2007, which accounts for the bill's October 1, 2006 effective date. This estimate reflects the cost of hiring one education specialist at MSDE to develop a grant application for the Kindergarten Plus Program, determine grant amounts for local school systems, aid in the implementation of the program, identify appropriate assessment tools, evaluate the effectiveness of the program, and report annually on the efficacy of the program. The fiscal 2007 estimate includes a full-time salary, fringe benefits, one-time start-up costs, and ongoing operating expenses. Future year administrative costs of \$80,000 to \$95,000 annually assume a full-year salary with 4.6% annual salary increase, 3% turnover, and 1% increases in operating expenses.

Beginning in fiscal 2008, the State will award grants to schools in which at least 85% of students are eligible for free and reduced price meals. Assuming the State pays almost all the costs associated with the program, general fund expenditures for grants to local school systems will increase by an estimated \$8.3 million. The following information and assumptions were used in calculating this estimate.

• There are 60 schools in 4 local school systems that would have to implement the Kindergarten Plus Program based on the 85% free and reduced price meal eligibility threshold. The school systems, number of schools, number of kindergarten classrooms in those schools, and estimated number of kindergarten students in the schools are shown below.

- The Kindergarten Plus Program would add 12 weeks to existing kindergarten programs, 6 weeks prior to the start of the 2007-2008 school year and 6 weeks at the end of the 2007-2008 school year.
- Each participating school would receive grants to provide:
 - one teacher per classroom (total estimated cost of \$3.2 million, based on one-third of the average local teacher salary plus 10% for benefits);
 - one paraprofessional per classroom (\$9,280 per paraprofessional for salary and benefits, or \$1.5 million);
 - student transportation (\$244 per student, or \$963,800);
 - school operations and maintenance (\$5,000 per school, or \$300,000);
 - professional development (\$450 per teacher, or \$71,100);
 - classroom instructional materials (\$2,000 per classroom, or \$316,000);

- school lunches and staff to prepare and serve the meals (\$8 per student per day, or \$1.9 million. MSDE advises that the federal government does not subsidize summer meals.); and
- pre-program and post-program assessments (\$10 each for each student, or \$79,000).

Future year grant estimates assume 3% annual increases and add approximately \$10 per participating student for the required first grade assessment. The projections assume the number of schools with 85% or more of their students receiving free and reduced price meals will remain relatively stable. Projected grants by local school system are shown in **Exhibit 3**.

Local Fiscal Effect: Under the assumptions described above, local school system revenues from State aid would increase by an estimated \$8.3 million in fiscal 2008. The majority of the additional aid, an estimated \$7.5 million, would be allocated to Baltimore City. The State aid would be used to extend kindergarten programs in high-poverty schools by 12 additional weeks each year. Future year grant amounts will increase with inflation.
