6. Purpose of Bill

Authorizing the creation of a State Debt not to exceed \$500,000, the proceeds to be used as a grant to the Board of Directors of the Cedar Lane Sports Foundation, Inc. for the construction and capital equipping of the Cedar Lane Sports Facility.

9. Description and Purpose of Grantee Organization (3000 characters maximum)

The Cedar Lane Sports Foundation has been created to develop, maintain, & manage a state-of-the-art regional sports facility in cooperation with the Harford County Dept. of Parks & Recreation. Playing surfaces & facilities of this park shall be designed & maintained at the highest of industry standards. This 14 field complex will accommodate a variety of field sports including, but not limited to field hockey, football, lacrosse, rugby & soccer. The Cedar Lane Sports Foundation is a non-profit organization with the goal of creating enhanced recreational opportunities for citizens of Harford County, as well as, residents of the entire mid-atlantic region. To date, the foundation has assumed full financial responsibility for completion of the facility design and securing local development advisory committee (DAC) approval. In short, the foundation envisions a premiere attraction and sports focal point for Harford County. A grant from the State of Maryland will insure that this vision can be actualized.

10. Description and Purpose of Project (3000 characters maximum)

Cedar Lane Park is a 110 acre site, conveniently located at the intersections of routes 136 & 543. As designed, the facility can accommodate 14 athletic fields. Engineered plans include 13 fullsized multi-purpose playing fields with minimum dimensions of 65 yards by 120 yards, one 90' baseball diamond, and 963 parking spaces. A walking trail throughout the park links the fields. All capital improvements will remain assets of Harford County. This facility will provide expanded programming opportunities for youth & adult participants and a much needed, state-of-the-art venue for general recreation use, travel team practices & games, regional tournaments, school team championships, leagues, clinics & other special events. It will alleviate the strain on more traditional recreation facilities & local school recreation complexes in Harford County. Specific relief will be afforded the Emmorton Recreation Council, providing a home football field and use of other facilities for critical needs. Cedar Lane Park will generate significant economic benefits to the County and State through the scheduling of tournaments, regional leagues & special events that now must take place out of the area. We believe that regional facilities may better address the expressed leisure needs of our burgeoning population & provide a practical solution to maximizing the utilization of limited open space, particularly for those living within the development envelope. This grant will provide the balance of funds required to complete site improvements necessary to bring the facility on line. Your consideration of this proposal is appreciated.
