Appropriations

### **Circuit Courts - Courtroom Security**

This bill requires county sheriffs to provide security for each courtroom in the circuit court used for family law and juvenile law cases beginning July 1, 2007, and to the extent provided in the State budget. The bill also requires the State to reimburse counties for expenditures relating to these security services.

The bill takes effect July 1, 2007.

## **Fiscal Summary**

**State Effect:** General fund expenditures could increase by \$9.1 million in FY 2008 and by \$9.3 million in FY 2011 to reimburse local jurisdictions for circuit court courtroom security in juvenile and family law cases.

**Local Effect:** Local expenditures could decrease by \$3.2 million in FY 2008 and by \$3.6 million in FY 2011 as a result of State reimbursement for salaries and fringe benefits for deputies currently assigned to circuit courtroom security in juvenile and family law cases.

Small Business Effect: None.

### Analysis

**Bill Summary:** The bill provides that this State funding: (1) does not relieve counties or county sheriffs from their duty to provide security to circuit courts; (2) should not be construed as an assumption by the State of any liability incurred by the county for its circuit court security services; and (3) does not modify any existing duty or liability of the State or a county, other than what is specifically mentioned in the bill.

The bill requires counties, beginning in fiscal 2008 and in each subsequent fiscal year, to use savings resulting from State reimbursement towards increasing local expenditures for circuit court or related public safety purposes. The bill also requires that the savings must be used to supplement, not replace, existing local expenditures for these purposes.

Counties must report to the Department of Budget and Management (DBM) by November 1 in fiscal 2008 through 2015 on the application of savings resulting from the bill. DBM will then report the application of this funding to the Chief Judge of the Court of Appeals and the General Assembly.

**Current Law:** The State does not currently reimburse counties for circuit court security. Circuit court security standards and policies vary by jurisdiction.

**Background:** This legislation is proposed as part of the Judiciary's *Updated Circuit Courts Action Plan.* The plan discusses a multiyear phase-in of State funded circuit court security for family law and juvenile law cases, beginning in fiscal 2008 with the five largest jurisdictions (Anne Arundel County, Baltimore City, Baltimore County, Montgomery County, and Prince George's County), and expanding to the remaining 19 jurisdictions in fiscal 2009.

**State Expenditures:** Based on figures provided to the Judiciary by local jurisdictions, general fund expenditures could increase by an estimated \$9,076,650 in fiscal 2008, which accounts for the bill's July 1, 2007 effective date, as shown in **Exhibit 1**. This estimate reflects the cost of reimbursing counties for expenses incurred to provide security in circuit courts for all juvenile and family law cases. It includes salaries, fringe benefits, one-time start-up costs, and ongoing operating expenses. The information and assumptions used in calculating the estimate are stated below:

• future year salaries and fringe benefits will increase by 4.6% annually, to reflect variations in annual salary increases and inflation in benefits in each local jurisdiction;

- each new deputy requires \$9,934 (one-time cost) in new equipment, based on the estimate provided by Harford County (\$9,836 in fiscal 2007 plus 1% inflation for fiscal 2008); and
- deputies currently assigned part-time to the circuit courts who will be assigned to circuit court full-time as a result of this bill will not need new equipment.

**Local Expenditures:** Local expenditures could decrease by \$3,184,812 in fiscal 2008, due to the State's reimbursement of salaries and fringe benefits for current deputies assigned to the circuit courts for juvenile and family law cases, as shown in **Exhibit 2**. Future year estimates reflect annual increases in salaries and fringe benefits of 4.6%.
