AMENDMENT NO. 1

On page 1 of the bill, in line 8, after "public" insert "<u>, beginning on a certain</u> <u>date</u>,".

On page 2 of the bill, in line 3, strike "declaring that nothing in this Act shall" and substitute "<u>providing that certain provisions of law may not</u>"; in line 5, strike "<u>providing for a delayed effective date</u>;"; and in line 36, strike "<u>24-510</u>" and substitute "<u>24-511</u>".

On page 1 of the Economic Matters Committee Amendments (SB0091/323097/1), in line 4 of Amendment No. 1, after "<u>circumstances</u>" insert "<u>before</u> <u>a certain date</u>; providing that a certain waiver terminates on a certain date</u>"; and in lines 11 and 12, strike "<u>Secretary of Health and Mental Hygiene</u>" and substitute "<u>health officer of a county</u>".

AMENDMENT NO. 2

On page 2 of the Economic Matters Committee Amendments, in Amendment No. 2, strike beginning with "<u>SHOP</u>" in line 13 down through "<u>PRODUCTS</u>" in line 16 and substitute "<u>BUSINESS THAT IS A SOLE PROPRIETORSHIP, LIMITED LIABILITY</u> <u>COMPANY, CORPORATION, PARTNERSHIP, OR OTHER ENTERPRISE, IN WHICH:</u>
