AMENDMENTS TO SENATE BILL 91, AS AMENDED

(First Reading File Bill)

AMENDMENT NO. 1

Strike the Finance Committee Amendments (SB0091/957079/1) in their entirety.

AMENDMENT NO. 2

On page 1 of the bill, in line 2, strike "Clean Indoor Air Act of 2007" and substitute "Restaurants and Bars – Smoking Permitted – Signs"; strike beginning with "prohibiting" in line 3 down through "employment" in line 22 and substitute "requiring certain restaurants and bars in which the smoking of tobacco products is permitted to post a certain sign in a certain location; establishing certain penalties; requiring the director of certain health facilities to post a certain sign in certain locations in which the smoking of tobacco products is permitted in a certain location; declaring that nothing in this Act shall be construed to preempt a certain entity from enacting and enforcing certain measures; and generally relating to required signage in areas in restaurants and bars that permit smoking".

On pages 1 and 2 of the bill, strike beginning with "BY" in line 23 on page 1 down through "Supplement)" in line 4 on page 2.

On page 2 of the bill, in lines 5 and 27, in each instance, after "repealing" insert "and reenacting, with amendments,"; in line 15, after "repealing" insert "and reenacting, without amendments,"; and strike in their entirety lines 21 through 26, inclusive.

On page 3 of the bill, strike in their entirety lines 1 through 11, inclusive.

AMENDMENT NO. 3

On page 3 of the bill, strike in their entirety lines 14 through 27, inclusive; in line 30, strike the bracket; and in line 32, strike "(3)" and substitute "(4)".

AMENDMENT NO. 4

On page 5 of the bill, after line 10, insert:

- "(3) (I) ANY RESTAURANT OR BAR IN WHICH THE SMOKING OF TOBACCO PRODUCTS IS PERMITTED SHALL POST A "SMOKING PERMITTED" SIGN IN A CONSPICUOUS LOCATION AT THE PUBLIC ENTRANCE OF EACH LOCATION.
- (II) A PERSON WHO VIOLATES SUBPARAGRAPH (I) OF THIS PARAGRAPH IS SUBJECT TO A CIVIL PENALTY OF:
 - 1. NOT MORE THAN \$500 FOR THE FIRST OFFENSE;
- 2. NOT MORE THAN \$1,000 FOR A SECOND OR SUBSEQUENT OFFENSE.";

in line 11, strike "(3)" and substitute "(4)"; and in line 13, strike the bracket.

On page 6 of the bill, in line 1, strike the brackets; strike beginning with "**NOTWITHSTANDING**" in line 1 down through the second "**THIS**" in line 2; in line 9, after "(2)" insert "(I)"; after line 11, insert:

On page 11 of the bill, in line 19, strike the bracket; and in line 21, strike "(3)" and substitute "(4)".

On page 13 of the bill, after line 3, insert:

On page 17 of the bill, in line 1, strike "4." and substitute "3.".
