On page 2, in line 19, after "<u>harvesting</u>;" insert "<u>requiring the Department to</u> provide certain publications to certain persons under certain circumstances; prohibiting a person from catching oysters for sale without providing certain certification to the Department;"; in line 29, after "<u>oysters</u>;" insert "<u>requiring a certain</u> amount of the oyster seed or spat produced at a certain laboratory to be made available to certain leaseholders for purchase;"; and in line 36, after "<u>4–204(c)</u>," insert "<u>4–701(e)(2)</u>,".

#### AMENDMENT NO. 3

On page 14, after line 8, insert:

"SECTION 3. AND BE IT FURTHER ENACTED, That one-tenth of the oyster seed or spat produced for planting in accordance with Section 1 of this Act at the University of Maryland Center for Environmental Science Horn Point Laboratory shall be made available for purchase to any leaseholder of land beneath the waters of the Chesapeake Bay and its tributaries who leased in accordance with Title 4, Subtitle 11A of the Natural Resources Article.";

in lines 9, 27, and 32, strike "3.", "4.", and "<u>5.</u>", respectively, and substitute "<u>4.</u>", "<u>5.</u>", and "<u>6.</u>", respectively; and in line 33, strike "<u>4</u>" and substitute "<u>5</u>".
