AMENDMENT NO. 1

On page 1, in line 4, after "permit" insert "<u>valid in certain counties</u>"; in lines 4 and 7, in each instance, strike "or a straight truck"; and in lines 9, 11 and 12, and 15 and 16, in each instance, strike "or straight truck".

On page 2, in line 5, after "Assembly;" insert "providing for the construction of this Act;".

AMENDMENT NO. 2

On page 2, after line 16, insert:

"(A) <u>AN EXCEPTIONAL MILK HAULING PERMIT ISSUED UNDER THIS</u> <u>SECTION IS VALID ONLY IN ALLEGANY COUNTY, ANNE ARUNDEL COUNTY,</u> <u>BALTIMORE COUNTY, CARROLL COUNTY, FREDERICK COUNTY, GARRETT</u> <u>COUNTY, HOWARD COUNTY, MONTGOMERY COUNTY, PRINCE GEORGE'S</u> <u>COUNTY, AND WASHINGTON COUNTY.</u>";

in line 20, after "IS" insert "<u>THE ONLY LOAD ON THE VEHICLE AND IS</u>"; in line 23, strike "(I) FOR A COMBINATION OF VEHICLES, HAS" and substitute "<u>HAS</u>"; and strike beginning with the semicolon in line 25 down through "AXLE" in line 27.

AMENDMENT NO. 3

On page 2, in lines 17, 28, and 30, strike "(A)", "(B)", and "(A)", respectively, and substitute "(B)", "(C)", and "(B)", respectively.

AMENDMENT NO. 6

On page 6, in line 21, after "Act" insert "is"; after line 27, insert:

"<u>SECTION 4. AND BE IT FURTHER ENACTED</u>, That nothing in this Act shall be construed to exempt a holder of an exceptional milk hauling permit from any applicable State or federal motor carrier requirements not specifically addressed in this Act.";

and in line 28, strike "4." and substitute "5.".
