On pages 2 and 3, strike in their entirety the lines beginning with line 18 on page 2 through line 9 on page 3, inclusive.

On page 3, after line 9, insert:

On page 10, in line 1, strike "\ 14-1202.1" and substitute "\ 14-1212.1".

## AMENDMENT NO. 3

On page 4, in line 24, strike "OR"; and in line 26, after the second "CONSUMER" insert "; OR

(10) TO THE EXTENT NOT PROHIBITED BY OTHER STATE LAW, A PERSON ONLY FOR THE PURPOSE OF SETTING OR ADJUSTING AN INSURANCE RATE, ADJUSTING AN INSURANCE CLAIM, OR UNDERWRITING AN INSURANCE RISK".

On page 12, in line 5, after "PRODUCED" insert "; OR

CONCERNING, AND USED SOLELY FOR:

- 1. CRIMINAL RECORD INFORMATION;
- 2. Personal loss history information;
- 3. FRAUD PREVENTION OR DETECTION;
- 4. EMPLOYMENT SCREENING; OR
- <u>**TENANT SCREENING**</u>".

#### AMENDMENT NO. 4

On page 5, in line 2, strike "Telephone" and substitute "Subject to Paragraph (5) of this subsection, telephone, by providing certain Personal Information that the consumer reporting agency may Require to Verify the Identity of the Consumer".

On page 6, after line 3, insert:

- "(5) (I) IF A CONSUMER REQUESTS PLACEMENT OF A SECURITY FREEZE BY TELEPHONE UNDER PARAGRAPH (1)(II) OF THIS SUBSECTION, THE CONSUMER REPORTING AGENCY MAY REQUIRE THE CONSUMER TO CONFIRM THE REQUEST IN WRITING ON A FORM THAT THE CONSUMER REPORTING AGENCY PROVIDES TO THE CONSUMER WITH THE MATERIALS SENT IN ACCORDANCE WITH PARAGRAPH (4) OF THIS SUBSECTION.
- (II) IF THE CONSUMER FAILS TO RETURN WRITTEN CONFIRMATION THAT THE CONSUMER REPORTING AGENCY REQUIRES UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE CONSUMER REPORTING AGENCY MAY REMOVE THE SECURITY FREEZE IN ACCORDANCE WITH SUBSECTION (G)(2) OF THIS SECTION."

On page 8, in line 7, after "IF" insert ":

<u>1.</u>";

in line 8, strike "PLACEMENT" and substitute "PLACEMENT"; and in line 9, after "CONSUMER" insert "; OR

On page 6, in line 27, strike "CERTIFIED MAIL" and substitute "MAIL IN THE MANNER PRESCRIBED BY THE CONSUMER REPORTING AGENCY"; and in line 28, after "TELEPHONE" insert "IN THE MANNER PRESCRIBED BY THE CONSUMER REPORTING AGENCY".

On page 10, in line 15, after "RECEIVED" insert ", OR WITHIN 3 BUSINESS DAYS STARTING JULY 1, 2008".

On page 11, in line 3, after "RECEIVED" insert ", OR WITHIN 15 MINUTES STARTING JANUARY 1, 2010, FOR CERTAIN REQUESTS".

- (III) A CONSUMER REPORTING AGENCY IS NOT REQUIRED TO TEMPORARILY LIFT A SECURITY FREEZE WITHIN 15 MINUTES UNDER SUBPARAGRAPH (II) OF THIS PARAGRAPH IF:
- 1. THE CONSUMER FAILS TO COMPLY WITH PARAGRAPH (1)(III) OF THIS SUBSECTION; OR
- 2. THE CONSUMER REPORTING AGENCY'S ABILITY
  TO TEMPORARILY LIFT THE SECURITY FREEZE WITHIN 15 MINUTES IS
  PREVENTED BY:
- A. AN ACT OF GOD, INCLUDING FIRE, EARTHQUAKE, HURRICANE, STORM, OR SIMILAR NATURAL DISASTER OR PHENOMENON;

- B. AN UNAUTHORIZED OR ILLEGAL ACT BY A THIRD PARTY, INCLUDING TERRORISM, SABOTAGE, RIOT, VANDALISM, LABOR STRIKE OR DISPUTE THAT DISRUPTS OPERATIONS, OR SIMILAR OCCURRENCE;
- C. A DISRUPTION OF OPERATIONS CAUSED BY ELECTRICAL FAILURE, UNANTICIPATED DELAY IN EQUIPMENT OR REPLACEMENT PART DELIVERY, COMPUTER HARDWARE OR SOFTWARE FAILURE INHIBITING RESPONSE TIME, OR SIMILAR DISRUPTION;
- <u>D.</u> <u>A GOVERNMENTAL ACTION, INCLUDING</u> EMERGENCY ORDER OR JUDICIAL OR LAW ENFORCEMENT ACTION;
- E. A REGULARLY SCHEDULED MAINTENANCE OF, OR UPDATE TO, THE CONSUMER REPORTING AGENCY'S CONSUMER REPORTING SYSTEM THAT OCCURS OTHER THAN DURING NORMAL BUSINESS HOURS; OR
- F. A COMMERCIALLY REASONABLE MAINTENANCE OF, OR REPAIR TO, THE CONSUMER REPORTING AGENCY'S CONSUMER REPORTING SYSTEM THAT IS UNEXPECTED OR UNSCHEDULED.
- (IV) A CONSUMER REPORTING AGENCY THAT IS UNABLE TO TEMPORARILY LIFT A SECURITY FREEZE UNDER SUBPARAGRAPH (III)2 OF THIS PARAGRAPH SHALL LIFT THE SECURITY FREEZE AS SOON AS IT IS AUTHORIZED OR OTHERWISE REASONABLY CAPABLE OF DOING SO.";

and strike beginning with "TELEPHONE," in line 21 down through "MAIL," in line 22 and substitute "FACSIMILE".

AMENDMENT NO. 7

On page 9, in line 21, after "ARTICLE" insert "OR AN IDENTITY THEFT PASSPORT UNDER § 8-305 OF THE CRIMINAL LAW ARTICLE"; and in line 22, after "REPORT" insert "OR PASSPORT".
