A BILL ENTITLED

1 AN ACT concerning

2 **State Holiday – Rosa Parks’s Birthday**

3 FOR the purpose of making a certain date the legal State holiday commemorating
4 Rosa Parks’s birthday; and providing that Rosa Parks’s birthday is a paid
5 holiday for State employees.

16 Preamble

17 WHEREAS, Rosa Louise Parks was a civil rights activist whom the United
18 States Congress dubbed the “Mother of the Modern Day Civil Rights Movement”; and

19 WHEREAS, Rosa Parks is famous for her refusal to obey a demand from bus
20 driver James Blake to relinquish her seat to a white passenger; and

1 WHEREAS, Her subsequent arrest and trial for this act triggered the
2 Montgomery Bus Boycott, one of the largest and most successful mass movements
3 against racial discrimination in history; and

4 WHEREAS, Rosa Parks received numerous awards, including the Presidential
5 Medal of Freedom, the Congressional Gold Medal, the Spingarn Medal, and the Rosa
6 Parks Peace Prize; and

7 WHEREAS, In order to celebrate and commemorate the life of Rosa Parks and
8 the outstanding contributions she made to American life, history, and culture; now,
9 therefore,

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Article 1 – Rules of Interpretation**

13 27.

14 (a) In this Code and any rule, regulation, or directive adopted under it, “legal
15 holiday” means:

16 (1) January 1, for New Year’s Day;

17 (2) January 15, for Dr. Martin Luther King, Jr.’s birthday, unless the
18 United States Congress designates another day for observance of that legal holiday, in
19 which case, the day designated by the United States Congress;

20 (3) **FEBRUARY 4, FOR ROSA PARKS’S BIRTHDAY;**

21 (4) February 12, for Lincoln’s birthday;

22 [(4)] (5) The third Monday in February, for Washington’s birthday;

23 [(5)] (6) March 25, for Maryland Day;

24 [(6)] (7) Good Friday;

25 [(7)] (8) May 30, for Memorial Day, unless the United States
26 Congress designates another day for observance of that legal holiday, in which case,
27 the day designated by the United States Congress;

1 **(4)** the third Monday in February, for Presidents' Day;

2 **[(4)] (5)** May 30, for Memorial Day, unless the United States
3 Congress designates another day for observance of that legal holiday, in which case,
4 the day designated by the United States Congress;

5 **[(5)] (6)** July 4, for Independence Day;

6 **[(6)] (7)** the first Monday in September, for Labor Day;

7 **[(7)] (8)** October 12, for Columbus Day, unless the United States
8 Congress designates another day for observance of that legal holiday, in which case,
9 the day designated by the United States Congress;

10 **[(8)] (9)** November 11, for Veterans' Day;

11 **[(9)] (10)** the fourth Thursday in November, for Thanksgiving Day;

12 **[(10)] (11)** the Friday after Thanksgiving Day;

13 **[(11)] (12)** December 25, for Christmas Day;

14 **[(12)] (13)** each statewide general election day in this State; and

15 **[(13)] (14)** each other day that the President of the United States or the
16 Governor designates for general cessation of business.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2007.
