## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Montgomery County –**  
3 **Old Blair High School Auditorium**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005  
5 to extend the date by which the Board of Directors of the Old Blair Auditorium  
6 Project, Inc. must present evidence that a matching fund will be provided for  
7 the Old Blair High School Auditorium grant.

8 BY repealing and reenacting, with amendments,  
9 Chapter 445 of the Acts of the General Assembly of 2005  
10 Section 1(3) Items ZA01(AR) and ZA02(AV)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:
