7 the Board of Public Works that a matching fund will be provided.

1 (AQ) Odd Fellows Hall. Provide a grant equal to the lesser of
2 (i) \$100,000 or (ii) the amount of the matching fund
3 provided, to the Board of Trustees of the Grand United
4 Order of Odd Fellows Sandy Spring Lodge # 6430, Inc.
5 for the repair, renovation, and preservation of the Odd
6 Fellows Hall, located in Sandy Spring, subject to a
7 requirement that the grantee grant and convey an
8 historic easement to the Maryland Historical Trust.
9 Notwithstanding Section 1(5) of this Act, the matching
10 fund may consist of in kind contributions or funds
11 expended prior to the effective date of this Act.
12 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT,**
13 **THE GRANTEE HAS UNTIL JUNE 1, 2009, TO**
14 **PRESENT EVIDENCE THAT A MATCHING FUND WILL**
15 **BE PROVIDED** (Montgomery County) 100,000

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 June 1, 2007.
