8 **(B) THE REPORT SHALL SET FORTH ANY RECOMMENDATIONS FROM**
9 **THE ADVISORY BOARD AND SUMMARIZE THE ADVISORY BOARD’S ACTIVITIES**
10 **DURING THE PRECEDING YEAR.**

12 July 1, 2007.
