4 ~~FOR the purpose of allowing certain individuals to claim a credit against the State~~
5 ~~income tax up to a certain amount for textbooks purchased for use at~~
6 ~~institutions of higher education; providing that the credit may not exceed the~~
7 ~~State income tax for that taxable year and that any unused credit for a taxable~~
8 ~~year may not be carried over to any other taxable year; defining certain terms;~~
9 ~~providing for application of this Act; and generally relating to a credit against~~
10 ~~the State income tax credit for certain textbooks.~~

11 FOR the purpose of establishing a Task Force to Study the Cost of Textbooks for
12 Higher Education; providing for the composition of the Task Force; requiring
13 the Maryland Higher Education Commission to provide staff for the Task Force;
14 prohibiting a member of the Task Force from receiving compensation; providing
15 that a member of the Task Force is entitled to reimbursement for certain

~~18 (a) There is a Task Force to Study the Cost of Textbooks for Higher
19 Education.~~

~~20 (b) The Task Force consists of the following members:~~

~~21 (1) one member of the Senate of Maryland, appointed by the President
22 of the Senate;~~

~~23 (2) one member of the House of Delegates, appointed by the Speaker of
24 the House;~~

~~25 (3) the Secretary of Higher Education, or the Secretary's designee;~~

1 (4) the Chancellor of the University System of Maryland, or the
2 Chancellor's designee;

3 (5) the President of Morgan State University, or the President's
4 designee;

5 (6) the President of St. Mary's College of Maryland, or the President's
6 designee;

7 (7) the following members, appointed by the Secretary of Higher
8 Education:

9 (i) one member of a board of community college trustees;

10 (ii) one student who is enrolled in a constituent institution of
11 the University System of Maryland;

12 (iii) one student who is enrolled in a community college;

13 (iv) one member of the faculty of a community college;

14 (v) one representative of a business that contracts with the
15 University System of Maryland or a community college to provide textbook selling
16 services on a university or community college campus;

17 (vi) one representative of a textbook publishing company whose
18 textbooks are sold to higher education students in the State; and

19 (vii) one representative of a business that buys and sells used
20 textbooks to higher education students in the State;

21 (8) one member of the faculty of a constituent institution of the
22 University System of Maryland, appointed by the Chancellor; and

23 (9) one representative of the Maryland Independent College and
24 University Association.

- 1 (c) The members of the Task Force shall elect a chair from the membership.
- 2 (d) The Maryland Higher Education Commission shall provide staff for the
3 Task Force.
- 4 (e) A member of the Task Force:
- 5 (1) may not receive compensation as a member of the Task Force; but
- 6 (2) is entitled to reimbursement for expenses under the Standard
7 State Travel Regulations, as provided in the State budget.
- 8 (f) The Task Force shall:
- 9 (1) examine retail prices of textbooks for higher education students in
10 the State, including average and median prices for undergraduate, graduate, and
11 community college student textbooks;
- 12 (2) study factors that impact retail prices of textbooks, including:
- 13 (i) how professors choose textbooks for their classes;
- 14 (ii) the amount retail booksellers increase retail prices above
15 publishers' list prices;
- 16 (iii) publishers' methods of setting list prices;
- 17 (iv) publishers' methods of marketing textbooks to professors;
18 and
- 19 (v) any other factors the Task Force identifies as impacting
20 retail prices paid by higher education students for textbooks; and
- 21 (3) develop recommendations for providing financial relief to students
22 and families relating to the price of textbooks.

1 (g) In performing its duties, the Task Force may invite all interested groups
2 and individuals to present testimony or other information to the Task Force.

3 (h) On or before September 1, 2008, the Task Force shall report its findings
4 and recommendations to the Governor and, in accordance with § 2-1246 of the State
5 Government Article, the General Assembly.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 July 1, 2007. It shall remain effective for a period of 2 years and, at the end of June 30,
8 2009, with no further action required by the General Assembly, this Act shall be
9 abrogated and of no further force and effect.
