1 (a) (1)Except as provided in subsection (b) of this section, the county 2 commissioners of every county may: 3 (i) Acquire by purchase, gift, devise, bequest, condemnation, or 4 otherwise, any property, or any interest therein, of any kind needed for any public 5 purpose: Erect buildings thereon for the benefit of the county; 6 (ii) 7 (iii) Sell at public sale any property when no longer needed for 8 public use; and 9 (iv)Provide for the financing of any housing or housing project 10 in whole or in part, including the placement of a deed of trust, mortgage, or other instrument upon the property to ensure repayment of funds used to purchase, 11 construct, rehabilitate, or otherwise develop the housing project. The authority 12 provided for in this subparagraph does not limit the existing powers of a county or 13 county commissioners. 14 15 (2)Property may not be sold until it has been advertised for at least 20 days prior to the date of sale. 16 17 The provisions of this subsection prevail over those of subsection (b) (1)(a) of this section to the extent of any inconsistency. 18 19 (5)(i) In Somerset County, the County Commissioners may sell 20 any interest in surplus property held by the county by acceptance of sealed bids 21 solicited by advertisement. 22 An advertisement for bids shall be published at least twice (ii) in a newspaper of general circulation in the county not less than 10 days nor more 23 24 than 90 days before the date set for opening the bids. 25 The bids shall be opened in public and the County (iii) Commissioners shall act on the bids only during a public session of the County 26 27 Commissioners. 28 If the County Commissioners determine that the highest bid (iv) 29 fails to yield a reasonable price for the property, the County Commissioners may reject 30 all bids on the property.

If the property is surplus school property, in accordance with paragraph (2) of this subsection. 7 8 The County Commissioners shall adopt a local ordinance or (vi)resolution governing the sale of property under this paragraph. 9 10 (d) (1) The County Commissioners of Somerset County may sell the property known as the old Somerset County Jail, located on 48 North Beckford 11 12 Avenue, Princess Anne, to the Town of Princess Anne. 13 (2) **(I)** THE PROVISIONS OF THIS SECTION DO NOT APPLY TO A 14 SALE OF PROPERTY UNDER THIS PARAGRAPH. **(II)** THE COUNTY COMMISSIONERS OF SOMERSET COUNTY 15 MAY SELL THE FOLLOWING PROPERTY TO THE CITY OF CRISFIELD UNDER 16 TERMS CONSIDERED APPROPRIATE BY THE COUNTY COMMISSIONERS: 17 1. 7 N.
