CHAPTER _____

1 AN ACT concerning

2 **Somerset County – Sale of Property to City of Crisfield**

3 FOR the purpose of authorizing the County Commissioners of Somerset County to sell
4 certain property to the City of Crisfield under terms the County Commissioners
5 consider appropriate; exempting the sale of certain property from certain
6 general requirements for the sale of surplus property; and generally relating to
7 the sale of county property in Somerset County.

8 BY repealing and reenacting, without amendments,
9 Article 25 – County Commissioners
10 Section 11A(a) and (b)(1) and (5)
11 Annotated Code of Maryland

13 BY repealing and reenacting, with amendments,

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 25 – County Commissioners**

4 11A.

5 (a) (1) Except as provided in subsection (b) of this section, the county
6 commissioners of every county may:

7 (i) Acquire by purchase, gift, devise, bequest, condemnation, or
8 otherwise, any property, or any interest therein, of any kind needed for any public
9 purpose;

10 (ii) Erect buildings thereon for the benefit of the county;

11 (iii) Sell at public sale any property when no longer needed for
12 public use; and

13 (iv) Provide for the financing of any housing or housing project
14 in whole or in part, including the placement of a deed of trust, mortgage, or other
15 instrument upon the property to ensure repayment of funds used to purchase,
16 construct, rehabilitate, or otherwise develop the housing project. The authority
17 provided for in this subparagraph does not limit the existing powers of a county or
18 county commissioners.

19 (2) Property may not be sold until it has been advertised for at least
20 20 days prior to the date of sale.

21 (b) (1) The provisions of this subsection prevail over those of subsection
22 (a) of this section to the extent of any inconsistency.

23 (5) (i) In Somerset County, the County Commissioners may sell
24 any interest in surplus property held by the county by acceptance of sealed bids
25 solicited by advertisement.

26 (ii) An advertisement for bids shall be published at least twice
27 in a newspaper of general circulation in the county not less than 10 days nor more
28 than 90 days before the date set for opening the bids.

29 (iii) The bids shall be opened in public and the County
30 Commissioners shall act on the bids only during a public session of the County
31 Commissioners.

1 (iv) If the County Commissioners determine that the highest bid
2 fails to yield a reasonable price for the property, the County Commissioners may reject
3 all bids on the property.

4 (v) If all bids are rejected, the County Commissioners shall
5 record the highest bid in the minutes of the public session and may proceed to sell the
6 property:

7 1. By readvertising for sealed bids;

8 2. By public auction; or

9 3. If the property is surplus school property, in
10 accordance with paragraph (2) of this subsection.

11 (vi) The County Commissioners shall adopt a local ordinance or
12 resolution governing the sale of property under this paragraph.

13 (d) (1) The County Commissioners of Somerset County may sell the
14 property known as the old Somerset County Jail, located on 48 North Beckford
15 Avenue, Princess Anne, to the Town of Princess Anne.

16 (2) (I) **THE PROVISIONS OF THIS SECTION DO NOT APPLY TO A**
17 **SALE OF PROPERTY UNDER THIS PARAGRAPH.**

18 (II) **THE COUNTY COMMISSIONERS OF SOMERSET COUNTY**
19 **MAY SELL THE FOLLOWING PROPERTY TO THE CITY OF CRISFIELD UNDER**
20 **TERMS CONSIDERED APPROPRIATE BY THE COUNTY COMMISSIONERS:**

21 1. **7 N. FIRST STREET, TAX MAP 101, GRID 22,**
22 **PARCEL 757 (.073 ACRES);**

23 2. **320-322 LOCUST STREET, TAX MAP 101, GRID**
24 **21, PARCEL 810 (.158 ACRES);**

25 3. **304 TYLER STREET, TAX MAP 102, GRID 11,**
26 **PARCEL 616 (.146 ACRES); AND**

27 4. **15 W. MAIN STREET, TAX MAP 103, GRID 1,**
28 **PARCEL 1373 (.386 ACRES).**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2007.
