## A BILL ENTITLED

1 AN ACT concerning

2 **Education – Teachers – State and Local Aid Program for Certification by the**  
3 **National Board for Professional Teaching Standards**

4 FOR the purpose of including the renewal of certain certification by the National  
5 Board for Professional Teaching Standards as part of a certain State and local  
6 aid program; altering the maximum number of teachers who may be selected to  
7 participate in a certain program; authorizing the State Board of Education to  
8 provide certain aid to certain participants for certain retakes of the National  
9 Board for Professional Teaching Standards assessment; extending a certain  
10 termination date; requiring the State Department of Education to request a  
11 certain amount of money needed to provide at least all eligible teachers with  
12 certain funds in a certain budget request; and generally relating to the State  
13 and Local Aid Program for Certification by the National Board for Professional  
14 Teaching Standards.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
7 MARYLAND, That the Laws of Maryland read as follows:

8 **Article – Education**

9 6–112.

10 (a) There is a program of State and local aid to teachers who pursue  
11 certification **OR RENEWAL OF CERTIFICATION** by the National Board for  
12 Professional Teaching Standards known as the State and Local Aid Program for  
13 Certification by the National Board for Professional Teaching Standards.

14 (b) Each school year, the State Board shall select, consistent with the  
15 amount provided in the State budget for the Program, a maximum of [750] **1,000**  
16 teachers to participate in the Program.

17 (c) **THE STATE BOARD MAY PROVIDE AID UNDER THE PROGRAM TO A**  
18 **PARTICIPANT FOR UP TO ONE RETAKE OF AN UNSUCCESSFUL ENTRY ON THE**  
19 **NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS ASSESSMENT.**

20 [(c)] (D) The State Board shall adopt regulations to implement and  
21 administer the Program established under this section, including:

22 (1) Procedures for submitting applications for aid; and

23 (2) Criteria for the selection of recipients of aid.

24 [(d)] (E) (1) [Each] **EXCEPT AS PROVIDED IN SUBSECTION (C) OF**  
25 **THIS SECTION, EACH** teacher selected by the State Board to receive aid shall receive  
26 from the State an amount equal to the certification fee charged by the National Board  
27 for Professional Teaching Standards.

28 (2) Each county shall pay to the State one-third of the cost of  
29 certification for each teacher who participates in the Program who teaches in the  
30 county.

1           (3) (i) A teacher who does not complete all the requirements for  
2 assessment by the National Board for Professional Teaching Standards shall  
3 reimburse the State the full amount of the aid received to participate in the Program.

4           (ii) The State shall reimburse the county the amount received  
5 under paragraph (2) of this subsection on receipt of the reimbursement of aid from a  
6 teacher under this paragraph.

7           (iii) The provisions of subparagraph (i) of this paragraph do not  
8 apply to a teacher who completes all the requirements for assessment by the National  
9 Board for Professional Teaching Standards but who does not receive certification.

10        [(e)] (F) The State Board shall establish a statewide staff development plan  
11 that utilizes the skills and knowledge of teachers who have obtained National Board  
12 certification.

15        SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 on June 1, 1997. It shall remain effective for a period of [11] **16** years **AND 1 MONTH**,  
17 and, at the end of [May 31, 2008] **JUNE 30, 2013**, and with no further action required  
18 by the General Assembly, this Act shall be abrogated and of no further force and  
19 effect.

20        SECTION 2. AND BE IT FURTHER ENACTED, That in making a budget  
21 request for the State and Local Aid Program for Certification by the National Board  
22 for Professional Teaching Standards under § 6–112 of the Education Article, the  
23 Maryland State Department of Education shall request the total amount of money  
24 that would be needed to provide at least all eligible teachers with funds to cover initial  
25 certification, renewal of certification, and the funding of up to one retake of an  
26 unsuccessful entry on the National Board for Professional Teaching Standards  
27 assessment.

28        SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 October 1, 2007.
