Consumer Protection - Contracts for Consumer Goods or Services - Delayed Payment

- 4 FOR the purpose of requiring that a certain consumer contract that allows a consumer 5 to delay payment of the purchase price or interest on the purchase price of certain consumer goods or consumer services shall state clearly the date on 6 7 which interest begins to accrue; providing that a violation of this Act is an 8 unfair or deceptive trade practice under the Maryland Consumer Protection Act 9 and is subject to certain enforcement and penalty provisions; defining certain 10 terms; and generally relating to delayed payments for consumer goods and consumer services. 11

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 MARYLAND, That the Laws of Maryland read as follows:

- 1 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE 2 MEANINGS INDICATED.
- 3 (2) "CONSUMER" HAS THE MEANING STATED IN § 13–101 OF THIS 4 ARTICLE.
- 5 (3) "CONSUMER CONTRACT" MEANS THE TOTAL LEGAL OBLIGATION THAT RESULTS FROM THE PARTIES' AGREEMENT RELATING TO THE SALE OR LEASE OF CONSUMER GOODS OR THE PROVISION OF CONSUMER SERVICES.
- 9 **(4) "CONSUMER GOODS" HAS THE MEANING STATED IN § 13–101** 10 **OF THIS ARTICLE.**
- 11 (5) "CONSUMER SERVICES" HAS THE MEANING STATED IN § 12 13–101 OF THIS ARTICLE.
- 13 (B) A CONSUMER CONTRACT THAT ALLOWS A CONSUMER TO DELAY
 14 PAYMENT OF THE PURCHASE PRICE OR INTEREST ON THE PURCHASE PRICE OF
 15 THE CONSUMER GOODS OR THE CONSUMER SERVICES THAT ARE SUBJECT TO
 16 THE CONSUMER CONTRACT SHALL STATE CLEARLY THE DATE ON WHICH
 17 INTEREST BEGINS TO ACCRUE.
- 18 (C) A VIOLATION OF THIS SECTION IS:
- 19 **(1) AN UNFAIR OR DECEPTIVE TRADE PRACTICE WITHIN THE** 20 **MEANING OF TITLE 13 OF THIS ARTICLE; AND**
- 21 (2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS 22 CONTAINED IN TITLE 13 OF THIS ARTICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2007.
