- FOR the purpose of altering the membership of the Maryland Agricultural Commission by requiring the Governor to appoint a member from a list of a certain number of nominees representing the biofuel industry; and generally relating to the Maryland Agricultural Commission.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

Article – Agriculture

16 2–203.

17 (a) The Commission has 29 members. One member is ex officio and is the 18 principal administrative official for agricultural affairs at the University System of 19 Maryland as designated by the Chancellor of the University. The Governor appoints 20 the remaining [28] **29** members as follows:
