4 5 6	(2) The State's Attorney may appoint two deputy State's Attorneys and [73] <b>80</b> assistant State's Attorneys. The deputy State's Attorneys and assistant State's Attorneys serve at the pleasure of the State's Attorney.
7 8 9 10	(3) The annual salary of the deputy State's Attorneys shall be within the discretion of the State's Attorney, but may not exceed [\$108,000] <b>\$115,000</b> . The salaries are to be paid by the county on the certification of the State's Attorney to the County Executive and County Council.
11 12 13 14	(4) The annual salary of the assistant State's Attorneys shall be within the discretion of the State's Attorney, but may not exceed [\$100,000] <b>\$107,000</b> . The salaries are to be paid by the county on the certification of the State's Attorney to the County Executive and County Council.
15 16 17 18 19 20 21	(7) The State's Attorney may appoint an administrative assistant to serve at the pleasure of the State's Attorney. The annual salary of the administrative assistant shall be within the discretion of the State's Attorney, but may not exceed [\$59,000] <b>\$64,000</b> . The salary is to be paid by the county on the certification of the State's Attorney to the County Executive and County Council. The administrative assistant is not subject to the rules and regulations of the county merit system, but shall be entitled to all benefits provided for county employees under the merit system.
