1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Anne Arundel County –**
3 **Maryland Hall for the Creative Arts**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to authorize certain matching funds required to be provided by the Board of
6 Directors of the Maryland Hall for the Creative Arts, Inc. to include in kind
7 contributions.

8 BY repealing and reenacting, with amendments,
9 Chapter 46 of the Acts of the General Assembly of 2006
10 Section 1(3) Item ZA00 (Z) and ZA02 (O)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:
