Higher Education – Dual Enrollment Grant Program

3 FOR the purpose of repealing certain provisions of law relating to the inclusion of 4 dually enrolled students in a certain part-time grant program; requiring the 5 Maryland Higher Education Commission to establish and administer a grant 6 program for dually enrolled students; requiring a recipient of a dual enrollment 7 grant to be a resident of the State and a dually enrolled student; requiring the 8 Commission to administer funds for the Dual Enrollment Grant Program and to 9 distribute funds to an institution of higher education on behalf of a dual enrollment grant recipient; requiring funds for the Dual Enrollment Grant 10 Program to be as provided in the annual budget of the Commission by the 11 Governor; requiring the Commission to establish guidelines for the awarding of 12 13 dual enrollment grants to dually enrolled students; requiring the Commission to adopt certain regulations; requiring the Governor to include certain funds in the 14 15 State budget for certain fiscal years for the Dual Enrollment Grant Program; 16 defining a certain term; and generally relating to the Dual Enrollment Grant 17 Program.

11 12 13	(1) Enrolled] ENROLLED in a degree–granting program at an eligible institution and taking at least 6 but no more than 11 semester hours of courses each semester[; or
14 15	(2) Dually enrolled in a secondary school in the State and an institution of higher education].
16 17 18	(b) [(1)] In cooperation with the institutions of higher education in the State, the Commission shall establish and administer a grant program for undergraduate part-time students.

IN THIS SECTION, "DUALLY ENROLLED STUDENT" MEANS A (A) 1 2 STUDENT WHO IS DUALLY ENROLLED IN: 3 (1) A SECONDARY SCHOOL IN THE STATE; AND 4 (2) AN INSTITUTION OF HIGHER EDUCATION IN THE STATE. THE COMMISSION SHALL ESTABLISH AND ADMINISTER A GRANT 5 **(B)** 6 PROGRAM FOR DUALLY ENROLLED STUDENTS. 7 (C) A RECIPIENT OF A DUAL ENROLLMENT GRANT SHALL: BE A RESIDENT OF THE STATE; AND (1) 8 9 (2) BE A DUALLY ENROLLED STUDENT. 18-14A-02. 10 (A) **FUNDS FOR THE DUAL ENROLLMENT GRANT PROGRAM SHALL BE:** 11 12 (1) **ADMINISTERED BY THE COMMISSION; AND** (2) **DISTRIBUTED TO AN INSTITUTION OF HIGHER EDUCATION ON** 13 14 BEHALF OF A DUAL ENROLLMENT GRANT RECIPIENT. 1 SECTION 2. AND BE IT FURTHER ENACTED, That, beginning with the fiscal 2 year 2009 State budget and each year thereafter, the Governor shall appropriate to 3 the Maryland Higher Education Commission for the administration of the Dual 4 Enrollment Grant Program established under Title 18, Subtitle 14A of the Education 5 Article, as enacted by Section 1 of this Act, an amount not less than 10% of the amount 6 appropriated to the Commission for the administration of the Part–Time Grant 7 Program established under Title 18, Subtitle 14 of the Education Article.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 June 1, 2007.
