# State Employee and Retiree Health and Welfare Benefits Program – Eligibility for Enrollment and Participation

4 FOR the purpose of allowing employees of the Southern Maryland Regional Library, 5 the Eastern Shore Regional Library, and the Western Maryland Regional 6 Library to enroll and participate in the health insurance benefit options 7 established under the State Employee and Retiree Health and Welfare Benefits 8 Program under certain circumstances; requiring a regional library to pay 9 certain costs to the State; requiring a regional library to make a certain determination; and generally relating to the participation in health and 10 insurance benefit options under the State Employee and Retiree Health and 11 Welfare Benefits Program by employees of the Southern Maryland Regional 12 Library, the Eastern Shore Regional Library, and the Western Maryland 13 14 Regional Library.
